#### WHY DID YOU CHOOSE THIS CAREER PATH?

I have always had a passion for nature, the environment and sustainable development, and therefore the choice to pursue Conservation Ecology was an easy one. However, I am not exactly cut out for life in the bush. therefore taking steps to become an Environmental Assessment Practitioner and conducting environmental impact assessments was the next logical thing. In my role I am able to facilitate sustainable development and waste management practices.

#### WHAT IS A TYPICAL DAY LIKE FOR YOU?

My work is a standard 8 - 5 office job, with some twists. I am mainly responsible for report writing (Basic Assessments and Environmental Impact Reports) which includes project management, liaising with authorities, clients, specialists (e.g. freshwater, botanical, visual, heritage) and stakeholders, doing the actual impact assessment using our company's methodology and notifying the public of our projects. I am also the main Environmental Control Officer (ECO) at my company, meaning I go to construction sites and monitor compliance with the approved Environmental Management Programme (i.e. I check their waste management is up to scratch and that they are not harming the environment during the construction phase).

#### WHAT DOYOU ENJOY MOST?

I enjoy working with a wide range of specialists and learning every day. Site visits (either for proposed projects or for my ECO work) takes me across the Western Cape – from Saldanha to Worcester to Stellenbosch, Luckily I enjoy writing, so the report writing is a fun bonus and I get to apply my mind daily to new challenges and projects. I also really enjoy the feeling when one of my projects gets approved and gets Environmental Authorisation - best feeling ever!
