Covid-19 & GBV

- During lockdown our households can be "sites of violence and abuse".
- Covid-19 pandemic has (like AIDS pandemic) exposed the social drivers of this "shadow pandemic", GBV
- Common vulnerability/ community
- New/ different 'normal'?

Church & GBV

- During Lockdown our households can be sites of worship.
- The 'Church' has (and continues to) "call out" social injustices such as racism, poverty, xenophobia...
- "We who are many are one body"
- New/ different ways of 'being' and 'doing' church



- "You declared apartheid evil and a sin, please declare gender-based violence to be evil and a sin as well





Some Proactive Responses: Prevention, Intervention Mitigation

- 1. Policy & guidelines on GBV ... to deal effectively when sexual harassment happens in the church; clear guidelines on what to do when one finds oneself in an abusive situation. This will open up the subject ... and open up safe spaces in the church for both victims and perpetrators.
- 2. Put in place (and support) a Gender ministry ... with concrete aims and goals and outcomes. Not only once off gender workshops often seen as something outside of church business.
- 3. Mainstream gender-justice and GBV interventions strategies in all aspects of church-life.
- 4. Encourage liberative/ transformative bible study approaches for women and men.

- 5. Be intentional about using gender inclusive language.
- 6. Pause ... Look and listen ... and hear the screams and see the suffering. GBV is the lived- reality for many women and girl children
- 7. Rethink the way things have always been understood/interpreted and done ... what we defend as 'tradition' ... Jesus challenged the status quo.
- 8. Remember that representation ≠ transformation
- 9. Intercede through Prayer ... be moved to act from Love in whose image we men and women are created.
