Prof Magda Slabbert:

Prof Slabbert is responsible for the subject Professional Ethics in the College of Law, Unisa. Her passion is Medical Law and she has published numerous articles on various topics in the fields of Medical Law and Ethics.

Dr Herman Edeling:

Dr Edeling is the vice chairperson of the SAMLS. He is a neurosurgeon that specialises in Road Accident Fund cases as well as medical negligence cases. Dr Edeling is extremely experienced especially concerning the Narrative test. He has been to court as an expert witness many times but he is also experienced in drafting reports necessary for medical claims. He is also a member of the Appeals Tribunal for RAF cases at the HPCSA.

Prof Lautenbach

Prof Lautembach is a well-known Orthopedic Surgeon from Johannesburg. He has unrivalled international experience in the field of chronic osteomyelitis and revision of infected joint replacements. During his career he has managed over 7,000 infected cases, successfully using a suction-irrigation system for antibiotic delivery and lavage. The aetiology of his patients ranged from post-arthroplasty and trauma, to lower limb infections in diabetics and spina bifida. Prof Lautenbach is a member of the Exco of the SAMLS.

Ms Karen Vermaak

Ms Karen Vermaak is an attorney in private practice as a partner in the law firm Munro Flowers and Vermaak. The firm specialises in medical negligence and personal injury cases. She therefore has extensive experience in such cases and in liaising with expert witnesses. Ms Vermaak is also a member of the Exco of the SAMLS.

Adv Albert Lamey

Adv Albert Lamey is a member of the Exco of the SAMLS and former chairperson of the Society. He is an advocate at the Bar in Pretoria. His fields of interest and expertise include inter alia professional ethics and medical negligence. Adv Lamey has practised for many years as a litigation attorney before he joined the Bar in 2012.

Dr Hennie Pienaar is the Treasurer of the SAMLS. He is a senior lecturer at the University of Pretoria and the SBAH, Department of Surgery. He has an extreme interest in the application of medical law and ethics.

Dr Burger has, *inter alia*, written extensively on the death notification form and death notification processes as applied in the South African context.
