News from the **Dean's office**

Dear member of our Faculty of Law Community

It gives me great joy to write to you whilst the final examinations for this academic year are taking place. There was a brief moment this year when it was uncertain whether we would be able to complete the academic year before the end of this calendar year. It is with great resolve and collaboration that we managed to do so, and I want to thank and congratulate staff and students for attaining this milestone.

It has been eight months since lockdown started and more than ever before we miss the interaction and connection with each other and all our students. Most staff have continued to work from home but the SU Law Clinic opened on campus again in June 2020. A highlight of this semester was the opening ceremony of the Preamble Art Installation in front of the Ou Hoofgebou (Old Main Building); it presented an opportunity for a small gathering of colleagues, which definitely added to the ceremony being a memorable occasion.

African Procurement Law Unit (APLU)

APLU's latest edited collection on public procurement law in Africa was published by LexisNexis. The book is entitled *Public Procurement Regulation in Africa: Development in Uncertain Times* and was edited by Professor Geo Quinot and Professor Sope Williams-Elegbe. The book comprises several essays focusing on public procurement regulation aimed at African development. Drawing on commentary from an extensive list of experts, including academics and professionals, the work outlines the legal landscape for procurement while pointing out the faults that allow procurement irregularities, including conflict of interest and corruption.

APLU also focused considerable attention on the impact of the COVID-19 pandemic on public procurement and vice versa. Professors Williams-Elegbe and Quinot presented at several virtual events on procurement and the pandemic. These included presentations by Professor Williams-Elegbe to the American Bar Association on "Anti-corruption and Compliance During COVID-19: Lessons learnt from the shut-down" and at the Social Outcomes Conference 2020 of the Government Outcomes Lab of Oxford University, entitled "Resilient Social Services Systems & Supply Chains Matter – Who Knew?!! What's Next". Professor Quinot presented on integrity issues in procurement

regulation at the VIII International Conference on Public Procurement – problems of law enforcement of the Moscow State University, and Quinot and Williams-Elegbe presented jointly on South Africa's handling of emergency procurement during the pandemic at a webinar hosted by George Washington University and Kings College London focusing on global lessons from procurement during the pandemic.

The long-awaited post-graduate programmes in public procurement law kicked off during the second semester of 2020. These are the LLM in Public Procurement Policy and Regulation and the PGDip in Public Procurement Policy and Regulation. Both these programmes are firsts, not only in South Africa, but on the continent in offering focused training in public procurement law from a distinct African perspective. Both programmes are also novel in the Law Faculty in that they are offered as professional programmes in a hybrid mode, meaning that students mostly study remotely and only attend block contact sessions once per semester.

HF Oppenheimer Chair in Human Rights Law

Virtual panel discussion on gender-based violence

The HF Oppenheimer Chair for Human Rights Law and the Transformation Committee of the Law Faculty presented a virtual panel discussion on gender-based violence as a human rights violation to mark Women's Month on 19 August. Professor Sandra Liebenberg, the Chair's incumbent, facilitated the panel discussion that focused on a range of critical issues surrounding gender-based violence. These ranged from South Africa's international law and constitutional obligations to address gender-based violence and femicide, to the roles of grassroots movements, religious institutions and educational institutions.

The panellists were legal and policy experts along with civil society activists. They were: Professor Bonita Meyersfeld, Ms Mandisa Khanyile, Advocate Bronwyn Pithey, Ms Joy Watson and Mr Hanzline Davids.

The panellists facilitated a critical discussion and invited participants to consider both the limits and potential of the law and grassroots movements for victims and survivors of gender-based violence. The event was extremely well-attended by over 120 participants. Read more about this event <u>here</u>.

Human rights and COVID conferences and webinars

In addition to participating in her final (virtual session) of the UN Committee on Economic, Social and Cultural Rights, Professor Liebenberg participated in a virtual international conference on 15 October 2020, organised by the Geneva Academy of International Humanitarian Law and Human Rights. She was one of the opening plenary panellists alongside the UN Deputy High Commission on Human Rights, Ms Nada Al-Nashif, and addressed the theme of "COVID-19 responses by the global and regional human rights systems." On 19 October,

she participated in a webinar organised by the Human Rights Law Centre, University of Nottingham entitled, "After the First Wave: Initial Conclusions on the Human Rights Impact of the COVID-19 Pandemic". She published an article on the theme of why human rights should guide states' COVID-19 pandemic responses in The Conversation which can be accessed <u>here</u>. In a recent interview, Mark Heywood and Prof Liebenberg discussed her role as UN Committee member, which can be accessed <u>here</u>.

Transformation and visual redress

Mr Gideon Basson, a research LLM-student working under the supervision of Professors Liebenberg and Botha, has been involved in various initiatives on transformation and visual redress. On 15 October, he was a presenter at the inaugural student transformation indaba on embedding empathy as a strategy for special needs students in residences and the implications for reasonable accommodation. He has also been actively involved in the Gender Detour initiative on campus, which aims to use campus as a walkabout to cue intentional conversations about the role of gender in campus culture, emotional and physical safety and health, social life, leadership, achievement and the future workplace. Second Annual Social Justice Summit

The Chair hosted the Second Annual Social Justice Summit on Wednesday 4 November 2020 from Spier wine estate in the heart of the Winelands. This second summit followed on from decisions taken during the inaugural event held in 2019. The virtual event facilitated the engagement of a wide audience, with over 400 registered attendees spanning 17 countries on four continents.

Professor Thuli Madonsela says: "Delegates signed a comprehensive resolution last year which committed them to the drive towards the eradication of inequality and the realisation of social justice. Our 2020 event was arranged to take this work further, and this was the key driving force behind the keynote speakers and the topics we chose for the day. Parallel breakaway plenary sessions in the afternoon delved deeper into themes that have an impact on the likelihood that social justice can be realised, such as land and poverty, economic inclusion and well-being, education and training, data analytics and poverty mapping, health, mental health and nutrition, access to justice and the rule of law, peace and social cohesion, climate change and environmental sustainability, politics and democracy, and gender and other excluded groups."

The keynote address was delivered by Justice and Correctional Services Minister, Ronald Lamola, in which he explained the role that government should be playing in the achievement of

social justice. "The role of the state, amongst other things, is to deepen equality in our society. Although we as a nation-state celebrate 25 years of being a constitutional and democratic state, we must be honest - obtaining social justice is still elusive in various communities and spheres of society in general. Politically, equality is afloat but social justice requires a substantial amount of work," Lamola told delegates. In his opening address, Professor Wim de Villiers injected a sense of agency in tackling the pressing challenges of poverty, inequality, unemployment and corruption, while addressing issues ranging from climate change to poverty and inequality particularly in the light of lessons learnt from the coronavirus COVID-19 pandemic and subsequent lockdown. Kate Robertson, who delivered the second keynote address from London, emphasised the importance of simplicity and impact-conscious communication, which she said was essential to bring the business community and others on board. She also highlighted the importance of involving young people and seizing opportunities presented by the UN Social Development Goals (SDGs) that seek to end poverty and reduce inequality by 2030. Clare Shine who delivered her keynote address from Salzberg, Austria drew parallels between the original Europe Recovery Programme popularly known as the Marshall Plan and the Social Justice M-Plan, endorsing the latter as timely and offering her support. Archbishop, Doctor Thabo Makgoba, gave a recorded message of hope emphasising the importance of uniting for social justice, fighting poverty and rebuilding better together in the post-COVID-19 recovery period. Busisiwe Mavuso (Chief Executive Officer of Business Leadership SA) and Doctor Adrian Enthoven

(Executive Chairman of Yellowwoods Investment Group), in turn, highlighted the importance of tackling economic growth and redistribution as twin challenges. They also outlined some of the measures business is undertaking to combat poverty and hunger while advancing socio-economic inclusion.

Gloria Serobe outlined the vision behind the Solidarity Fund initiative, its milestones to date, particularly regarding combatting hunger and destitution in rural areas and supporting PPE acquisition initiatives for rural areas. She supported the Social Justice M-Plan and called for the strengthening of synergies. At Boshoff reminded the gathering that social justice is a responsibility, and part of the tradition, of the faith community and called upon all to step up against poverty and hunger.

"We invited them to speak on how their various sectors worked towards bridging the equality gap and incorporating the SDGs in the work done by the organisations and sectors they represent. A similar panel discussion later in the day also saw several University vice-chancellors speak on this topic," says Madonsela.

Social Justice champions

The announcement of the Social Justice Champions of the Year was a highlight of the Social Justice Summit. The result was a culmination of a process where members of the public were asked to nominate and vote for community builders whose work is visible in closing the inequality gap while eradicating poverty. The joint winners for 2020 are Kabelo Mahlobogwane

(co-founder and Managing Director at The Marking App for teachers), and Eon Hendricks (founder of the Clay Foundation that is empowering young people in Idas Valley). Madonsela said the process would be democratised in the coming year by reaching out beyond social media avenues such as Twitter and Facebook.

Co-chaired by Professor Wim de Villers, Principal and SU Vice-Chancellor and Basetsana "Bassie" Kumalo, successful media entrepreneur and former Ms South Africa, the Council will drive the Musa Plan for Social Justice (Social Justice M-Plan), which was launched at the Summit. Other members include Wendy Ackerman, Doctor John Kani, Justice Edwin Cameron, Justice Yvonne Mokgoro, Mr Sello Hatang, Ms Doreen Morris, Ms Kate Robertson, Ms Busisiwe Mavuso, Ms Felicia Mabuza-Suttle, Doctor Beatrice Wiid, Mr Ashraf Garda, Advocate Xoli Maduna, Professor Sakhela Bhulungu, Professor Francis Petersen, Professor Adam Habib and Ms Lindiwe Mazibuko. According to De Villiers, the University is on a journey of renewing its institutional culture, which includes what is visually apparent in the spatial layout, visual iconography and visible symbolism on its campuses.

"We want to unite the University community with symbols that heal and help us move forward together. And this installation is part of that ongoing process," Professor De Villiers said.

"It will be a constant reminder of the framework provided by the Constitution, which also guides us as a University community. It is an expression of our commitment to democratic values, social justice and human rights; and of the need to improve the quality of life of all citizens and to build a united South Africa." The installation, in celebration of the Constitution of South Africa, comprises three separate metal plates depicting the preamble to the Constitution in three languages (Afrikaans, English and Xhosa). Water cutting technology was used to excise the words of the preamble on the plates.

The installation was designed by well-known landscape artist, Strijdom van der Merwe. Also speaking at the event, Van der Merwe said that he has fond memories of taking classes in the Ou Hoofgebou many years ago: "Little did I know that after so many years, I would be able to make a contribution to transformation at Stellenbosch University through art."

He gave an overview of the artwork and said that, amongst others, he was particularly careful to create a sculpture that would not distract from the front view of the building as the Ou Hoofgebou is often used as a visual symbol of the University. Van der Merwe adds that the collaborative nature of the project makes it special. "We started with a particular idea, but the design went through a number of changes as we received input from various role-players to get to where we are now." Another dynamic feature of the artwork is that the text from each plate is projected onto the ground as the sun shines through the plates at certain angles and at certain times of the day. "In this way, a dynamic experience is created between the text and the

passer-by to 'experience' the preamble as it were", Van der Merwe explains.

Background/Intsusa-mabandla

In providing the background to the event, Professor Nicola Smit, Dean of the Faculty of Law, said that the Preamble project was conceived as part of the broader visual redress process of the Faculty of Law. The Faculty initiated the project in 2017 as part of SU's visual redress process that aims to add art and symbols to the University's campuses giving effect to the institution's vision of an inclusive institution committed to a transformative student experience, amongst others. Professor Geo Quinot coordinated the project, which involved a comprehensive consultation process involving, amongst others, the SU Visual Redress Committee, Faculty staff and students and the SU Management, as well as external role-players.

Professor Smit reflected on the importance of the art installation, "Our memories of the past together with this new visual reminder of the aspirations of the people of South Africa, including all of us, provide us the opportunity to use memory (both past and present, individual and collective) to grow our relationships with all people in an inclusive and reflective manner. From the start, it was important to us that the Preamble of the Constitution will act as a physical link between the public space outside the Ou Hoofgebou and the Faculty of Law, symbolising a society anchored in a constitutional democracy and the importance of access to justice and the realisation of social justice for all. I believe that you will all agree with me that we have achieved that goal with this beautiful artwork and now what remains is to live up to the promise of our Constitution." Comments Dr Leslie van Rooi, Senior Director: Transformation and Social Impact: "We believe that art installations such as this one will contribute to transforming our spaces to be welcoming, inclusive and increasingly diverse as envisaged in the University's *Vision 2040 and Strategic Framework 2019-2024*. It creates opportunities to encourage reflection and conversations about lessons from the past and the possibilities of our future as enshrined in our Constitution. This process of reflection started in the late 1990's and was again highlighted as a priority during and after the Fees Must Fall protests," says Van Rooi.

"What we want to achieve with this art installation is to contextualise the Ou Hoofgebou as part of our heritage by placing a contemporary work of art, which represents the spirit of our time, next to the classical architecture of the building. SU wants to open a discourse on art at local and national level as part of our visual redress process."

The Ou Hoofgebou was inaugurated in November 1886. The Faculty of Law, that will celebrate its centenary in 2021, has been housed in the Ou Hoofgebou since its inception in 1921. (Part of this text was provided by Martin Viljoen)

Certificate Programme in Labour Dispute Resolution Practice

For the past seven years, Professor Christoph Garbers from the Department of Mercantile Law has presented the Certificate Programme in Labour Dispute Resolution Practice to not only upskill people involved in the day to day practice of labour law, but to also prepare interested participants for their roles as practising commissioners of the CCMA and panellists of bargaining councils. The CCMA, of course, is the largest labour dispute resolution institution in South Africa and is called on to resolve around 300 000 labour disputes per year – dealing mostly with unfair dismissal, unfair labour practice and unfair discrimination disputes. From there a constant need for welltrained individuals to assist in this function.

Presented in conjunction with the CCMA, the course focuses on a combination of principle and practice and, as such, makes use of a wide array of established academics, practitioners and commissioners for its presentation. The course has proved to

be very popular (it has grown to where we have around 170 participants per year). In total, 1 181 students have participated in the programme over the past seven years and it has delivered a large number – 681 – successful students as potential commissioners of the CCMA. In the latest round of applications for the post of commissioner of the CCMA, 87 former students applied for the position of commissioner. And, as recently as 2018, by far the majority of appointments to the CCMA were made from the Stellenbosch course (more than from all the other public universities combined in the period 2016-2018). One particular source of pride for the Faculty has been the diversity of students participating in the programme. We have been able to consistently maintain a level of 85% of students from the African, Coloured and Indian demographic groups and we have been able to deliver 543 successful African, Coloured and Indian students as potential commissioners.

Internationalisation/Internasionalisering

The Dean, Professor Nicola Smit, reports that the Faculty has finalised two new educational agreements with leading international faculties of law with two more agreements which are close to finalisation. "It is important that our students have opportunities to study at international partners and so

Pathways agreement with Cambridge University

The Faculty of Law has successfully concluded a pathways agreement with the Faculty of Law of Cambridge University. Whilst Cambridge has maintained such agreements with top Australian universities since 2014, this is the first agreement with a university in Africa. The agreement will allow students from Stellenbosch to undertake three and a half years of full-time law study at Stellenbosch and three terms at Cambridge. Successful completion of the <u>LLM</u> or <u>Masters degree</u> in <u>Corporate Law (MCL)</u> at Cambridge will be accepted by Stellenbosch in recognition for the final semester modules of the LLB Programme.

Professor Jens M. Scherpe, the Director of International Strategy and Partnerships at Cambridge University commented: "We are delighted to extend our network of pathways agreements, and to forge links with one of the leading African law schools. The pathways agreements attract outstanding students to undertake the LLM or MCL at Cambridge, and we are looking forward to

LLM Educational agreement with KU Leuven/LLM Opvoedkundige ooreenkoms met KU Leuven

The Stellenbosch and KU Leuven Faculties of Law wish to promote mobility of students and to cooperate in the area of teaching. To promote these aims an agreement was concluded to allow a number of KU Leuven students, under certain conditions, to enrol concurrently for one of the Master in Law (LLM) programmes at SU, while pursuing their Initial Master in Law at KU Leuven. In terms of the agreement a maximum of 15 students from KU Leuven may spend one academic year registered in the SU LLM programme and such year of successful studies at SU will be recognised by KU Leuven towards their programme. At the same time a new Student Exchange agreement, which also covers undergraduate students, was also concluded in order to promote student mobility even further. Stellenbosch law students interested in this programme, must independently apply to Cambridge University during their penultimate year of their LLB degree and must take note of their relevant application procedures and deadlines. Selection criteria apply and successful students will commence their studies at Cambridge University in October of their final year of the LLB programme. Once students have completed the full degree requirements at Cambridge University for the award of the LLM or MCL, Stellenbosch will credit students for the modules in the final semester of the LLB and students will graduate from SU.

New appointments

Professor Shannon Hoctor

Professor Shannon Hoctor's teaching and research focus is in criminal justice and legal history. He holds BA LLB and LLM degrees from the University of Cape Town (UCT), a postgraduate diploma in Latin from the University of Wales Trinity Saint David, and DJuris from the University of Leiden in the Netherlands, for a thesis entitled "The Crime of Housebreaking in South African Law – A Comparative Approach". Professor Hoctor's academic career began at UCT's Faculty of Law as a part-time lecturer in specific crimes before he took up a contract teaching post at the University of Port Elizabeth (UPE), where he was later appointed to a senior lectureship teaching criminal law and jurisprudence. After his promotion to associate professor at UPE, Professor Hoctor took up a chair in law at the University of Natal (now the University of KwaZulu-Natal) in Pietermaritzburg, where he has taught since 2002.

Professor Hoctor served as Deputy Dean of the Faculty of Law at the

University of KwaZulu-Natal from 2010 to 2011. He has published numerous articles in law journals, along with several chapters in books, and has authored 12 books in criminal law, statutory offences and road traffic law, including five edited works. He has served as editor-in-chief of the South African Journal of Criminal Justice since 2010, of Fundamina – A Journal of Legal History since 2019, and as assistant editor of Obiter since 2002. He is also a member of the Academic Advisory Board for the European Journal of Crime. Criminal Law and Criminal Justice. He has a C2 NRF rating. Professor Hoctor is a member of the Selden Society, the Stair Society, the South African Branch of the International Law Association (SABILA), and is the current President of the Southern African Society of Legal Historians. When not musing abstractedly about the unending philosophical depths of criminal law, Shannon likes to partake of red wine, dark chocolate and crime fiction - preferably all at the same time!

Doctor Delano Cole van der Linde

Doctor Delano Cole van der Linde is a Senior Lecturer and Subject Chair (Criminal Law and Criminal Procedure) at the Faculty of Law, North-West University (NWU). He has taught several modules at NWU, including Criminal Law (General Principles and Specific Crimes) as well as Legal Interpretation. He has also organised intercampus student conferences, including the 2018 student conference on gender-based violence and the 2019 conference on youth leadership.

He obtained his degrees (LLB, LLM and LLD) from SU. His main field of research is organised crime. His doctoral dissertation, wherein he strongly advocates for legislative reform, details the issues surrounding Chapter 4 of the Prevention of Organised Crime Act 121 of 1998. His further research interests are cross-cutting and include criminal procedure, law of evidence, corruption, policing and criminal justice. Some of his most recent publications include "Poverty as a Ground of Indirect Discrimination in the Allocation of Police Resources – A Discussion of Social Justice Coalition v Minister of Police 2019 4 SA 82 (WCC)" (Potchefstroom Electronic Law Journal); "Evidentiary and procedural issues relating to the Prevention of Organised Crime Act" (South African Law Journal); "The overlap between the common law and Chapter 4 of the Prevention of Organised Crime Act: Is South Africa's anti-gang legislation enough?" (South African Journal of Criminal Justice; forthcoming). He is currently a Junior Editor of the *Potchefstroom Electronic* Law Journal and serves on the editorial board of the Tydskrif vir die Hedendaagse Romeins-Hollandse Reg (Journal of Contem*porary Roman-Dutch Law)* and is a member of the *Vereniging* Hugo de Groot. In 2020 he received funding from the NRF to conduct postdoctoral research which enabled him to expand on

Over the years, the SU Faculty of Law, has actively participated in the All African Human Rights Moot Court Competition (AHRMC) hosted by different universities across the continent. In fact, we have an excellent track record in this event and in 2013, SU was runners up while in 2016, we came out as the winners.

This year's competition was hosted by the Université Virtuelle de Sénégal (UVS) and Université Cheikh Anta Diop de Dakar (UCAD). For the first time the competition was hosted virtually. This SU team's journey started with intensive reading of the hypothetical case, *NGO Liberty and Others and the State of Donamistan*. With the theme of this year's AHRMC being human rights in the digital age, the irony of this was not lost on them! Doctor Elvis Fokala (the team's mentor and coach and post-doctoral fellow in the Faculty of Law) reports that over the next few months the team worked hard engaging with our continent's fascinating human rights paradigm to produce written memorials. The heads of arguments, provided legal arguments on jurisdiction, juristic persons, freedom of expression, communications interception, corruption and technology.

Doctor Elvis Fokala says, "While arguing against teams before a virtual panel of judges was a daunting prospect, we were excited to finally give our arguments and the issues they raised a voice."

He adds, "I am proud to announce that our hard work paid off and the SU law team was awarded the ninth best memorials and fifth best team of 29 participating English-speaking teams. The oralists were also ranked amongst the top 10 best speakers on the African continent, with Ms Claire Rankin ranking fifth and Mr Nicholas Carroll ranking eighth in the En-

All African Human Rights Moot Court Competition 2021

Preparations for the 2021 All African Human Rights Moot Court Competition (AHRMC) were formally launched on 7 September 2020 in Stellenbosch, South Africa, when the Director of the Centre for Human Rights, University of Pretoria, Professor Frans Viljoen, the Vice Rector (Research, Innovation and Postgraduate Studies) of SU, Professor Eugene Cloete, together with the Dean of the Faculty of Law, Stellenbosch University, Professor Nicola Smit, signed the Memorandum of Understanding.

The thirtieth edition of the competition will take place from 25 July to 1 August 2021, in Stellenbosch, South Africa. Given the disruptions caused to the academic calendar due to COVID-19, the organisers agreed to adjust the previously announced dates. The theme is "We are all different – we are all equal".

Hosting the 2021 The AHRMC in Stellenbosch will mark an important milestone for each of the partners. The Centre for Human Rights will be celebrating the thirtieth anniversary of the African Moot Competition. The host, the SU Faculty of Law, will in 2021 be commemorating its Centenary.

The local organising committee is headed by Professor Annika Rudman, who is a professor in the Department of Public Law. Her scholarly interests are focused on the African human rights system, and she has participated in numerous AHRMCs. The SU Law Faculty is delighted to partner with the Centre for Human Rights welcoming participants from the breadth and length of the African continent to the Southern tip of Africa. The AU Agenda 2063 is the point of departure in the official moot slogan "From human wrongs to human rights" and the motto for the 2021 moot competition is therefore that, "We are all different – we are all equal". Equality, difference and identity will be the leading themes in 2021; spurring students participating in the competition to explore human diversity through a human rights lens, recognising all that brings us together in our differences.

Update on the SU Law Clinic & others/ National Credit Regulator & others

On 13 December 2019 the Western Cape High Court issued its landmark "statutory *in duplum*" judgment in favour of the applicants, the effect being that all amounts (including legal fees) that accrue under the National Credit Act against the debtor during the time that they are in default, are limited to the arrears debt at the time of default. The judgment has been appealed by the Legal Practice Council and Bayport, effectively suspending its immediate impact. "The appellants" Practice Note, Certificate in terms of rule 10, Chronology and Heads of Argument are due by 9 November 2020. We remain positive that the Court of Appeal's judgment will confirm and strengthen the decision of the High Court. The Clinic has allocated many of its resources to the institution of the pending class action to give effect to the terms of the judgment.



SU Law Clinic/Lifestyle Legal case

As a reminder: LegalWise South Africa has filed an intervention application to be joined as applicants in the pending certification application. According to papers filed at court, LegalWise has received "numerous complaints from its members describing the same harassment and threats and consequences as described by the applicants in the main application". In addition, the Payment Association of South Africa (PASA) has applied to intervene as amicus curiae (friend of the court) to assist the court in the matter.

The application for certification in order to pursue class action against Lifestyle Legal and their websites was initially scheduled to be heard in the Western Cape High Court on 21 to 22 April 2020. As a result of COVID-19, the matter was unfortunately removed from the roll and set down for 5 and 6 October 2020. Regrettably, due to unforeseen circumstances outside the Clinic's control, the Registrar has informed the parties that a judge cannot be allocated to hear the matter on the dates as set down. After these two unfortunate postponements, we are pleased to report that a new hearing date for the application for certification in order to pursue class action against Lifestyle Legal and their websites, has been arranged for 27 and 28 January 2021. The application for the interventions from LegalWise and PASA will be heard along with the certification application.

Clinic's practical legal training students

During September, the Clinic's Practical Legal Training students had the privilege of attending two synchronous webinars with the esteemed Advocate Chris Marnewick. SC (author of Litigation skills for South African Lawyers). Addressing the students through an online platform, Marnewick offered his personal take on fact analysis, pursuing the theory of a case, and practical cross-examination techniques. Marnewick used witness statements from the infamous Oscar Pistorius trial to highlight the importance of understanding the legal basis upon which examiners build their cases, as well as using those statements to extract the one relevant detail that could sway the court's opinion in favour of their client. It was a privilege listening to an expert of his calibre speak, and we appreciate him taking the time to offer his experience and wisdom.

Senior attorney and lecturer Stephan van der Merwe delivered an online presentation at the recent University of Pretoria International Consumer Law Conference during 21 to 23 September. He discussed a pending class action case of the Clinic that is supported by Professor Theo Broodryk's ground-breaking empirical research.

The Clinic is the organisation that assists the greatest

number of clients in eviction matters in the Western Cape. Over the past year (from 1 October 2019 to 30 September 2020), notwithstanding the COVID-19 pandemic and the Clinic being closed to the public from 26 March 2020 to 21 June 2020, the attorney and candidate legal practitioners in the Clinic's eviction department, opened files for 95 clients with eviction-related problems. Further the Clinic finalised 121 matters of clients with eviction related problems over

the past year. The eviction department is currently working on 198 pending files for clients with eviction related matters. From 1 October 2019 to 30 September 2020, the Clinic successfully finalised 26 eviction applications, either by reaching mutually acceptable settlement agreements that were made orders of court, or by successfully opposing the eviction applications in court.

As mentioned in the previous newsletter, the Clinic has also successfully assisted

36 families from farms in Stellenbosch, Paarl, Simondium and Wellington, respectively, with their relocations from the farms on which they resided. These families have all been relocated to properties that have, or will soon be, registered in the clients' names, following the Clinic's negotiations on their behalf. In these matters, financial assistance is offered to the farm occupiers by the farm owners, with the aim to enable the occupiers to relocate from the farms, and the Clinic would then be requested to assist the occupiers with advice on their rights, as well as with assistance in the negotiations with the farm owners or their attorneys. These negotiations most often result in farm occupiers receiving ownership of homes, which ultimately results in permanent security of tenure.

As a result, the Clinic not only assists clients with opposing eviction applications, providing legal advice on the Prevention of Illegal Eviction Act (PIE) and Extension of Security of Tenure Act (ESTA), threatening evictions, and applications to restore their possession of the properties on which they reside, but also with negotiations before or after court applications have been instituted.

Law Clinic taking the lead with eviction matters/ Regskliniek neem leiding met uitsettingsake

Die Regskliniek is die instansie wat die grootste aantal kliënte in die Wes-Kaap met uitsettingskwessies bystaan. Die prokureurs en kandidaatregspraktisyns van die Kliniek se uitsettingsdepartement het die afgelope jaar (van 1 Oktober 2019 tot 30 September 2020) vir 95 kliënte lêers oopgemaak met kwessies verwant aan uitsettings - dít ondanks die COVID-19-pandemie en die feit dat die kliniek vanaf 26 Maart 2020 tot 21 Junie 2020 vir die publiek gesluit was.

Verder kon die Kliniek tydens die afgelope jaar 121 lêers vir kliënte met uitsettingskwessies finaliseer. Die departement

werk tans aan 198 aktiewe lêers van kliënte wat deur uitsettingskwessies in die gesig gestaar word. Vanaf 1 Oktober 2019 tot 30 September 2020 het die Kliniek ook 26 uitsettingsaansoeke wat in howe teen kliënte ingestel is, suksesvol afgehandel, óf deur wedersyds aanvaarbare skikkingsooreenkomste wat as hofbevele bekragtig is, óf deur die suksesvolle opponering van uitsettingsaansoeke wat deur howe van die hand gewys is.

Soos in die vorige nuusbrief genoem, het die Kliniek ook 36 gesinne van plase in Stellenbosch, Paarl, Simondium en Wellington, onderskeidelik, suksesvol bygestaan met hul hervestiging vanaf die plase waarop hulle gewoon het. Nadat die Kliniek die onderhandelinge namens hierdie gesinne behartig het, het die gesinne almal verhuis na eiendomme wat nou op hul name geregistreer is of binnekort so geregistreer sal word. In hierdie hervestigingsonderhandelinge waarmee die Kliniek bystand verleen, bied die plaaseienaars finansiële steun aan die plaasokkupeerders, om hulle in staat te stel om die wonings op die plaas te ontruim. Die Kliniek word dan versoek om dié mense oor hul regte te adviseer en hulle by te staan met onderhandelinge met die plaaseienaars of hul prokureurs. Hierdie proses van onderhandelinge lei dan gewoonlik daartoe dat plaasokkupeerders eienaarskap van hulle eie wonings ontvang, wat lei tot permanente verblyfsekerheid vir die okkupeerders.

Die Kliniek help dus nie net kliënte om uitsettingsaansoeke te opponeer, of om kliënte te adviseer oor PIE- en ESTA-wetgewing, dreigende uitsettings en aansoeke om kliënte se besit van die eiendom waarop hulle woon, te herstel nie, maar ook met onderhandelinge voor of ná enige hofaansoeke ingestel word.

Law Clinic continues fight for consumer protection and debt justice

In the Clinic's senior attorney Stephan van der Merwe's South African Law Journal (2019) publication entitled "Too simple for National Credit Act matters: Reconsidering the scope of Magistrates' Courts rule 5(2)(b)", he argued for an amendment to the Rules of the Magistrates' Courts to encourage more transparency in litigation based on the National Credit Act. The content of this article was echoed by the Clinic in our relevant submissions to the Rules Board. We are pleased that the Rules Board recently published amendments to the rules in accordance with these suggestions, to come into operation on 1 December 2020. We view this development as another important step in the efforts to increase consumer protection and debt justice.

Legal writing project/ Regsskryfprojek

In line with the precautionary measures taken by SU's Law Faculty in response to COVID-19, all in-person writing consultations with the writing consultants are being discontinued and available online via Skype/Zoom of MS Teams for 2020. Although the consultants had to overcome many obstacles this year, we were encouraged and inspired by the support of our colleagues, as well as our students' commitment and enthusiasm in relation to their academic responsibilities. To assist students during unprecedented and difficult times has been a challenge, but definitely also a privilege.

We are also very proud to announce that our Legal writing development online short course will be launched in 2021. Please keep the course in mind for any legal practitioners that require a refresher <u>course</u> for their legal writing or needs to improve their writing.

Financial literacy project

Since COVID-19 and the start of lockdown in March, we asked the students to change their in-person presentations to a digital PowerPoint presentation, video and/or podcast. We divided the theme of financial literacy in 6 subthemes: Wants and needs, National Credit Act, Consumer Protection Act, Budgeting, Financial planning, and General spending tips. Their presentations were translated and both Afrikaans and English videos were sent to 11 schools and 21 farms in the surrounding area. Accordingly, the students shared their knowledge, and the project reached its objective.

The Clinic will close to the public on 11 December 2020 and will reopen on 7 January 2021.
