### Nuus van die Dekaan se kantoor

Ons staan aan die einde van ons Eeufees en sluit die jaar af met 'n feesviering van ons studente se (virtuele) gradeplegtigheid op 13 Desember. Tydens die in-persoon gradeplegtigheid later op dieselfde dag, verwerf twee doktorale studente hul grade en word die ere-doktorsgraad in regsgeleerdheid onderskeidelik aan Fritz Brand en Nicky Newton-King toegeken. Buiten die voorgraadse-, hoër diploma- en meestersgraduandi is soveel as 149 doktorale graduandi asook 30 ere-doctorandi (29 LLD en 1 DPhil) teen einde 2021 afgelewer. Die finale aantal graduandi van ons Fakulteit se eerste 100 jaar sal ons na afloop van die Maart gradeplegtigheid kan bepaal. Ons is baie trots op hierdie mylpale en dankbaar vir so 'n mooi afsluiting van 'n soms uitdagende jaar.

Daar is ook ander goed in die tweede helfte van hierdie jaar waaroor ons dankbaar is; onder andere, ons gesondheid, assesserings in persoon wat nie deur beurtkrag gekniehalter is nie, die enkele geleenthede om as fakulteit saam te kom na 'n lang tydperk van slegs virtuele skakeling, uitstekende aansoeke van voornemende studente vir die 2022-inname (daar was altesaam sowat 9 000 aansoeke vir I 20 LLB posisies), die feit dat 'n goeie aantal van ons finalejaar-studente wel hul internasionale semester uitruilstudies kon opneem, die suksesvolle afloop van die African Human Rights Skynhof Kompetisie, erkenning verleen aan ons personeel se prestasies, en die opwinding om die eerste graduandi van nuwe nagraadse programme af te lewer.

Ons was egter spyt om ons eeufees tuiskomsnaweek te moes kanselleer toe die COVID-19 getalle middel van die jaar toegeneem het. Dit is egter met groot vreugde wat ek jul uitnooi om die datums van 25-26 Maart in jul dagboeke aan te teken. Ons beplan 'n heerlike naweek vir alumni in die algemeen asook alumni van spesifieke jaargroepe; die gala dinee sal Saterdagaand 26 Maart plaasvind en ons hoop dat jul by ons sal aansluit. Verdere inligting sal vroeg in 2022 volg.

# News from the Dean's office

We have arrived at the end of the year, and we are concluding the year and our Centennial celebrations by celebrating our students' (virtual) graduation on 13 December. During the in-person graduation ceremony later that day, two doctoral students will receive their degrees, and honorary doctorates will respectively be awarded to Fritz Brand and Nicky Newton-King. In addition to the undergraduate, higher diploma, and master's graduates, as many as 149 doctoral degrees as well as 30 honorary doctorates (29 LLD and one DPhil) will have been conferred by the end of 2021. We will be able to determine the final number of graduates of our Faculty's first 100 years after the March graduation ceremony. We are very proud of these milestones and grateful for such an excellent conclusion to an occasionally challenging year.

There are other things that we are grateful for in the second half of this year; among others, our health, in-person assessments not hampered by load shedding, the few opportunities to come together as a Faculty after a long period of only virtual engagements, excellent applications from prospective students for the 2022 intake (there were a total of about 9 000 applications for 120 LLB positions), the fact that a good number of our

final-year students were able to pursue their studies in foreign semester exchange programmes, the successful completion of the African Human Rights Moot Court Competition, recognition of our staff's achievements, and the excitement of conferring degrees to the first graduates of new postgraduate programmes.

We were, however, saddened to have to cancel our centenary homecoming weekend when the COVID-19 numbers increased mid-year. However, it is with great pleasure that I invite you to take note of the new dates, 25 to 26 March 2022, and to mark these in your diaries. We are planning a wonderful weekend for the alumni in general as well as the alumni of specific year groups; the

gala dinner will take place on Saturday evening, 26 March, and we hope you will join us. Further information will follow early in 2022.

You have already received a notice about the Centenary publication, "Stellenbosch Law Faculty 100 years: Cupidae legum iuventuti" (Home - Law Trust (sun.ac.za)). I would like to thank the Law Trust that made this publication possible and would also like to take this opportunity to thank our alumni who annually support the Faculty and her students financially and otherwise. I would also like to draw your attention to the gallery of class photos (from 1930-2020) that is now available on the Law Trust's website.

I believe that the Faculty's 101st year will be the beginning of another meaningful journey. The roll-out of our undergraduate programmes (which have been updated in recent years through thorough programme renewal), in our second century of legal education, is also symbolic of such a new journey. ### Roundtable on cloud computing procurement

Science and Computational Thinking, and the School of Public Leadership to host a roundtable discussion on building capacity in the South African public sector for the procurement of cloud computing. The roundtable was exploratory in nature and brought together public sector organisations, including procurement officers, academics, to taking the initiative forward through a working group.

### **Procurement** Watch

Professor Geo Quinot of the African Procurement Law Unit collaborated with a leading NGO, namely Corruption Watch, in launching its new Procurement Watch online data tool and its first Procurement Watch Report on Procurement Risk Trends. The Procurement Watch tool consolidates data published by the National Treasury on deviations from procurement procedures, expansion of procurement contracts, and restrictions of government suppliers to allow for the analysis of such data. In this way, trends in deviations, expansions, and restrictions can be identified and further investigated to monitor public entities' compliance with procurement rules. The report and tool were introduced in a two-part webinar series in which Professor Quinot explained the relevant rules behind public procurement and the importance of this new monitoring mechanism.



### Women-Owned **Business in Public Procurement** Report

Professor Sope Williams-Elegbe completed a research report for the Open Contracting Partnership into Equity and Inclusion of Women-Owned Business in Public Procurement in South Africa in November 2021. The report was launched at the end of November.





# Comments on the Copyright Amendment Bill

Professor Sadulla Karjiker was invited to make oral submissions to the Portfolio Committee on Trade and Industry, 11 August 2021. The Portfolio Committee held hearings on the Copyright Amendment Bill and the Performers Protection Amendment Bill, which were remitted by the President in 2020. Professor Karjiker presented his comments and criticisms for the Portfolio Committee's consideration and suggested that expert legal review of the Bills is required.

### Intellectual Property Law for Science, Engineering, and Technology (SET)

The IP Chair, in conjunction with the Centre for Learning Technologies, is working hard on developing the new IP law service course for SET students. This module

will be presented in hybrid-learning form and aims to introduce students in science, engineering, and technology (SET) to the core concepts of intellectual property law, which are relevant to their fields of study. The Chair believes that this module will greatly benefit SET students in equipping them with the necessary knowledge of the law to assist them in their studies and future work endeavours. The Chair looks forward to piloting this course in 2022.

### **Annual IP Public Lecture 2021**

The Anton Mostert Chair of Intellectual Property Law hosted its annual Intellectual Property Law Public Lecture on 7 October 2021. Professor Dr Thomas Hoeren from the Institute on Information, Telecommunications, and Media Law (ITM) at the University of Münster addressed the guests on "IP Law in the Light of the Information Society". It was a thought-provoking lecture on the value and protection of information in the digital age. This was the first in-person event held at the Faculty since the start of the pandemic. The Chair values the importance

of face-to-face engagements, and the event would not have been possible without the guests' willingness to attend, albeit under strict COVID-19 protocols. For the first time in almost two years, attendees were able to interact without the constraints of confusing technology or unreliable Internet connections. The Chair along with the sponsors, Von Seidels IP Attorneys, considered the public lecture to be a great success and an encouraging sign of a return to normalcy.

# HF Oppenheimer Chair in Human Rights Law

### Media

On 12 July 2021, Professor Sandra Liebenberg published an opinion piece on the constitutional implications of the termination of the COVID-19 R350 Grant in Daily Maverick.

Based on an <u>academic article</u> published in the South African Journal on Human Rights, Professor Liebenberg published an article in The Conversation, entitled <u>Making Economic Policy in Hard Times</u>: <u>The Role of Human Rights</u>. This article was repub-


lished in several other publications, and Professor Liebenberg also gave radio interviews based on this article.

Professor Liebenberg also contributed an article to a leading human rights blog, OpenGlobalRights, in November 2021. The article is entitled What Chile can Learn from South Africa about Social Rights.

# Annual Human Rights Lecture

On 20 May 2021, the Chair hosted the 15th Annual Human Rights Lecture. The lecture was delivered by Judge Navi Pillay, former United Nations High Commissioner for Human Rights. The title of the lecture was "South Africa's Engagement with International Human Rights Law". Due to COVID-19 restrictions, the lecture was held via MS Teams. The event was very well attended with over 150 participants, and received extensive media coverage in News24, City Press, and Daily Maverick, amongst others.

The lecture was published in a commemorative booklet (available on our <u>website</u>) to mark the Centenary of the Faculty. The lecture will also be published in the forthcoming edition of the Stellenbosch Law Review.



### National and International Impact

Professor Liebenberg was invited to present at two workshops on policy proposals for basic income support after the termination of the COVID-19 R350 grant at the end of April 2021. The first presentation was on 4 October to a range of academic researchers in government, civil society, and academic institutions working on the feasibility of introducing a basic income grant in South Africa. The second presentation on 29 October was to members of the Expert Panel appointed by the Department of Social Development on Basic Income Support. Both presentations focused on the policy implications of social security as a human right enshrined in the Constitution as well as regional and international human rights instruments.


Professor Liebenberg chaired several sessions for the Drafting Group of the Maastricht IV Project to develop international legal principles and guidelines on the Human Rights of Future Generations. In addition, she continues to serve in an academic support capacity on the working group of the United Nations Committee on Economic, Social, and Cultural Rights to develop a General Comment on Sustainable Development and Economic, Social, and Cultural Rights. In this capacity, she moderated sessions of the African regional consultations of the Committee held on 3 September.

Professor Liebenberg was also invited by the Scottish Human Rights Commission to participate in an Expert Roundtable Discussion on the concepts of "progressive realisation" and "minimum core obligations". This Roundtable was held on 29 September and formed part of several initiatives to domesticate international human rights treaties, including the International Covenant on Economic, Social, and Cultural Rights in Scottish law.

### Conferences

On 6 and 7 December, Professor Bradley Slade and Professor Sandy Liebenberg presented a paper entitled, "Bringing a human rights lens to poverty and economic inequality: The role of the SA Human Rights Commission", at a virtual international conference. The conference, titled *Democratic Constitutions*, *Poverty, and Economic Inequality:* Redress beyond the Courts, was organised by the Gilbert and Tobin Centre of Public Law, Faculty of Law, University of New South Wales.

### Project Phakama

Gideon Basson, an LLM Candidate working under the Chair, partnered with the Mandela Rhodes Foundation and UN Women during 2021. The collaboration aimed to develop a model intervention for the high number of girls and women not in education, employment, and training ("NEET") between the ages of 14 to 25 in Sub-Saharan African countries. Gideon worked with other Mandela Rhodes Scholars from the African continent and developed *Project Phakama*, which means *rise up*. *Project Phakama* is an integrated policy, design, and stakeholder mapping for service and development programmes, based on models related to national civilian

services. Gideon crafted the integrated policy framework that situates Project Phakama within the Banjul Charter and Maputo Protocol. Drawing from these instruments, *Project Phakama* seeks to enhance the realisation of girls' and women's rights to development, education and training, work, equal access to employment, gender equality, and non-discrimination. This framework serves as the basis to expand *Project Phakama* within existing policy frameworks to ensure optimal uptake within the broader social and governance systems. UN Women was impressed by the project and invited Gideon to continue spearheading the project with them.

### LLD Candidate: Christiaan van Schalkwyk



From 14 to 18 June, Christiaan van Schalkwyk, an LLD Candidate under the Chair, participated in a short course on the interlinkages between economic, social, and cultural rights and the Sustainable Development Goals (SDGs) presented by the Geneva Academy of International Humanitarian and Human Rights Law. Lecturers on the course included former United Nations Special Rapporteurs, members of the Office of the High Commissioner on Human Rights, NGO-, and civil society representatives. Christiaan found the course extremely enriching and helpful to his LLD study on the concept of sustainable development and its potential to serve as a bridge between the right to a healthy environment and socio-economic rights in the Bill of Rights.

From 16 to 20 August, he also participated in a virtual writing research course hosted by the Postgraduate Office. The purpose of the workshop was to provide a productive virtual space for participants to share research and receive feedback on converting it to publications.

# Law Faculty Trust Chair in Social Justice

### **Announcements**

Professor Thuli Madonsela was requested by President Cyril Ramaphosa to serve on the panel tasked with compiling a shortlist of suitable candidates for the position of Chief Justice from nominations by the public. The panel chaired by the retired Judge of the International Criminal Court (ICC), Navanethem

"Navi" Pillay, included the Minister of Justice and Correctional Services, Ronald Lamola; the former Minister of Justice, Jeff Radebe; co-chair of the South African National AIDS Council, Ms Mmapaseka Steve Letsike, and Professor of Law at Howard University School of Law, Professor Ziyad Motala.



### **Events**

The Chair, together with the Council of Social Justice Champions, convened the 2nd Annual Social Justice Conference and the 3rd Annual Social Justice Summit, on 11 and 12 October 2021, at the Boschendal Conference Centre outside Franschhoek. "The events gave us an important opportunity to take stock of the progress we have made since the inaugural Conference and Sum-

mit in 2019 where we unanimously adopted a declaration that commits us to implement a Marshal Plan-styled Social Justice M-Plan," Professor Madonsela says. The Conference focused on emerging academic scholarship and innovative technologies seeking to advance social justice. It succeeded in providing a platform for sharing ideas on leveraging academic scholarship for social impact research, innovation, and training to help governments and corporate decision-makers to integrate social justice considerations in their policy design and product development to accelerate progress towards economic parity and inclusion.

The Social Justice Summit reflected on the progress achieved since the adoption of the Social Justice Declaration at the inaugural summit (in 2019) regarding the advancement of equality and the elimination of poverty through leveraging the global Sustainable Development Goals (SDGs).

One of the key outcomes of the Summit is an agreement to advocate for a law or clause in existing legislation, which will require the government to certify that the law or policy it intends to pass will advance equality and diminish poverty and not exacerbate the circumstances of these two social justice imperatives. Further agreement was reached to design and promote a model law, and to collaborate to design tools for the predictive impact assessment of laws and policies.

### Parliamentary Submissions

The Social Justice M-Plan has undertaken to make submissions to Parliament for Bills open for comment. The M-Plan is the flagship programme of the Law Trust Chair in Social Justice and aims to leverage data analytics to enhance the state's capacity to pass laws that reduce poverty and inequality and foster a culture of data-based decision-making.

In line with this, the Chair made several written submissions to Parliament and was afforded an opportunity to make oral representations on the Expropriation Bill and to present at a Parliamentary Webinar on a Just Transition. The Expropriation Bill presentation dealt with social justice considerations regarding the proposed expropriation without compensation. The presentation on a Just Transition, on 2 November 2021, dealt with the inclusive transition to green energy, amongst other things. Submissions to Parliament are meant to ensure that the relevant Bills respond to social justice issues and aim to reduce inequality. In 2021, submissions were made on the Expropriation Bill, Land Court Bill, Gender-Based Violence Bills, and Disaster Management Bill. The approach of the team involves that their submission process commences with a tabular summary of the changes in the act for an amendment or a summary of the bill for new legislation. They then convene a roundtable discussion with relevant stakeholders on the bill. Thereafter the submission is drafted and submitted to Parliament.

Professor Elmien du Plessis, from North-West University, facilitated the collaboration with the Chair for the Land Court Bill submission. Collaborations, (such as with Professor Du Plessis and Professor Zsa-Zsa Boggenpoel,) have been invaluable in making well-informed submissions.

The three amendment GBV Bills, i.e., Criminal and Related Matters Amendment Bill, Criminal Law (Sexual Offences and Related Matters) Amendment Act Amendment Bill, and Domestic Violence Amendment Bill are crucial and urgent given the levels of gender-based violence in this country. The roundtable on these bills included a representative from the Department of Justice and Constitutional Development who gave the context on these bills and why they all needed to be amended at the same time. Also present were researchers, GBV activists, and NGOs. Three separate submissions for each Bill were submitted; according to news reports, the Bills were adopted by the parliamentary committee on II August 2021. The Disaster Management Bill was different because it was a private member bill. It was also important to make comments on this bill because it shows that in a working democracy, private members can propose to amend or introduce new legislation.

The Law Trust Chair in Social Justice looks forward to ensuring that the government continues making impact-conscious policies through this democratic process.

### Gaming for Social Justice




# A good year for collaboration, a good year for property law research

luta's Property Law Library is a book series aimed at revisiting and reassessing the whole of South African Property law and the transformation of South African law and society. Each book in the series is a monograph focused on a specific aspect of property law. As the Chair of the South African Research Chair in Property Law, Professor Zsa-Zsa Boggenpoel, in collaboration with Professor Juanita Pienaar (Vice-Dean: Research and Internationalisation) and Professor Gerrit Pienaar (NWU), is responsible for overseeing the volume editing of new publications that form part of the Juta Property Law Library series. This results in various collaborations and the possibility of book publications in the future. Four books were launched this year at the South African Property Law Teachers Colloquium, hosted by the University of Free State from 10 to 12 November 2021, showcasing the Stellenbosch University Law Faculty connection. Three of the books are published under the Juta Property Law Library series, with Professor Juanita

Pienaar as the volume editor. These books are Planning Law, Sectional Titles, and Property in Housing.

The *Property and Pandemics: Property Law Responses to COVID-19* edited collection – a book project spearheaded by the SARCPL – was also launched at the Colloquium. The Chair invited interested researchers to submit research abstracts for proposed chapters for this edited collection. The editors were Professor Boggenpoel, Dr van der Sijde, Dr Tlale, and Ms Mahomedy. The edited collection deals with a stunning array of topics, including homelessness during the pandemic, the position of tenants who may face potential eviction due to outstanding rental, women's property rights, the constitutionality of the lockdown regulations, the effect of the pandemic on the property market, rural property rights, and insights from a range of theoretical perspectives on property law's systemic response to the pandemic.

All in all, despite the numerous challenges posed by COVID-19, it was indeed a good year for collaboration and a good year for property law research.

### **Pavocat Stellenbosch Academy (PSA)**

In July, SU through the Faculty of Law entered into a in highly focused and customised ways. The PSA is long-term collaboration agreement with the Pavocat Group of London to establish the Pavocat Stellenbosch Academy (PSA), based in the Faculty. The main aim of the PSA is to develop and deliver relevant, focused, and highly practical short courses globally for professionals practising in the fields of counter-corruption, laws of conflict, and related fields of law, who are intended to assist in countering corruption and to improve adherence to laws of conflict. The PSA will also analyse the possibilities, appropriate approaches, and methodologies to provide research and technical assistance in those fields.

By means of the PSA, the academic expertise of Stellenbosch University and highly practical experience of Pavocat (earned at the coalface of counter-corruption and law of conflict struggles around the world) are combined in a synergy that can offer gold-standard training. Such training will have a real impact in addressing corruption, compliance, and law of conflict challenges

governed by a board chaired by Pavocat director and founder Lee Marler, an alum of the Faculty and recently appointed extraordinary professor in the Department of Public Law; the board includes Professor Geo Quinot, Professor Sope Williams-Elegbe, and Dr Delano van der Linde of the Faculty.

### **COVID-19:** Ethics Under Pressure

The 2021 Stellenbosch University Law Clinic Legal Ethics / Ethics in Law Conference, supported by the International Association of Legal Ethics and the Stellenbosch University Faculty of Law, was hosted online on Monday and Tuesday, 29 and 30 November, from 14:00 until 20:00 SAST.

The conference provided an important platform to enable conversation and debate between legal ethicists, academics, professionals, philosophers, and enthusiasts interested in the fields of legal ethics and ethics in law. The conference formed part of the Centenary celebrations of the Stellenbosch University Faculty of Law and was free to attend.

The keynote address, entitled "The Ethics of Teaching and Lawyering in Treacherous Circumstances", was delivered by Professor Thuli Madonsela. Expert panels were conducted on Ethics and Legal Education, Public Interest Litigation, and Ethics and Lawyering in Politically Turbulent Times. The panels consisted of foremost international specialists and were chaired by Justice Edwin Cameron, Dr Helen Kruuse, and Advocate Geoff Budlender SC. The conference also included various presentations on contemporary and controversial topics related to legal ethics.

The conference was well received and provided thought-provoking and challenging debate.

# Revised undergraduate law curriculum

Following a three-year process of curriculum renewal, which followed the adoption of a national standard for the LLB in 2015 and review of all university programmes leading to the LLB, SU's Senate approved a revised undergraduate law curriculum in 2021. The revised curriculum will be phased in from 2022, starting with the new firstyear LLBs, and will be fully implemented across all years by 2025 when the 2022 intake will reach the final year. The revised curriculum will eventually apply to all undergraduate law programmes - LLB, BA(Law), BCom(Law), and BAccLLB. The revision of the curriculum provided the Faculty with an opportunity to thoroughly and critically re-evaluate what and how we teach undergraduate students and to make adjustments to align the curriculum with contemporary needs. These include the much higher levels of use of Information and Communication Technologies (ICTs), not only in teaching, but also in the practice of law. In this regard, the revised curriculum will include two new modules focusing on law and technol-

ogy - one compulsory module in the final year, Law and Technology 414, as well as an advanced elective module on law and technology. Other notable adjustments include a new first-year Foundations of Law module to introduce students to the broader context of law and legal traditions; introducing students to areas of law in a commercial context, like labour law earlier in the curriculum; clustering criminal justice modules in the third year, including a new module Criminal Justice in Action; and introducing a stand-alone compulsory Legal Ethics module in the second year. A very important further development is that clinical legal training, that is, training within the SU Law Clinic, will become compulsory for all final-year students. Across the curriculum, there will also be more integrated attention to the development of key skills and competences such as communication, information management, organising self and managing others, ethical conduct, social awareness, and professionalism.



# 2021 African Moot Court Competition

The 2021 African Moot Court Competition was held at the Faculty from 20 to 25 September 2021. This marked the 30th anniversary of the Competition and formed an important part of the Centenary Commemorations of the Faculty. The high-profile event brought more than 40 students and 50 African scholars, judges, and law practitioners to the Faculty. Professor Annika Rudman was the chair of the local organising team. It gave the participating students a unique opportunity to experience and learn from diverse cultures, legal systems, languages, and socio-economic realities.

The five-day gathering included several high-profile events involving leading African scholars in human rights law, Judges from the South African Constitutional Court, Justices from the African Court, and the European Court of Human Rights. The Moot Competition itself took place over three days; two days were dedicated to the quarter-final and semi-final rounds, and one day to the final round. Teams from 14 African Universities were represented in the Competition:

In the English stream, Kenyatta University and Stellenbosch University went through to the final; while in the French and Lusophone streams, Université Felix Houphouët Boigny

de Cocody and Universidade Eduardo Mondlane respectively made it to the final. The final of the Competition was held on Heritage Day and was judged by Professor Madonsela; as the Judge President; Professor Laurence Burgorgue-Larsen; of the European Court of Human Rights; Dr Solomon Dersoo, Chairperson of the African Commission on Human and Peoples' Rights; Former Justice Angelo Matusse, from the African Court on Human and Peoples' Rights; and Hon Robert Nanima, the Commissioner of the African Committee on the Rights and Welfare of the Child.

As the rules of the Competition prescribe, there was a

draw of lot regarding the team constellation in the <u>final</u> <u>round</u> and which side each combined team would represent. Our team was teamed up with the team from Universidade Eduardo Mondlane to represent the Respondent state, and Kenyatta University together with Université Felix Houphouët Boigny de Cocody represented the Applicants. The Applicant side won the competition with the <u>Respondents</u>, <u>Megan Roos and Shaniaé Maharaj from SU</u>, as proud runners-up.

As part of the event, the Faculty hosted the related African Human Rights Annual Conference, which was held in a hybrid format to enable the presentation of 18 papers online and in-person. The topics of the deliberations were developed into two streams; Theme I focused on women and sexual and gender-based violence (SGBV), and Theme II focused on diverse gender identities and expressions. The conference was live streamed in the two different streams and gathered more than 300 views online. Our Chancellor, former Justice Edwin Cameron, gave the Keynote Address in the first stream connecting anti-queer attitudes on our continent with the oppression of women. He pointed out that gender equality is indispensable to human flourishing, human rights, democracy, and the rule of law; he continued to point

out that gender-based violence, in all its forms, damages our pursuit of these ideals. SGBV, the Chancellor went on to say, promotes a heteronormative society and perpetuates patriarchy, which strips dignity and rights from women, girls, and LGBTIQ+ people. The Keynote Address in the second stream was provided by Ms Liberty Matthyse, the Executive Director of Dynamix, the first Africa-based NGO to focus solely on trans- and gender-diverse communities. She spoke passionately about the need to protect transgender persons from the plight of SGBV and the marginalisation of trans- and gender-diverse communities on the continent. As part of the Faculty's centenary celebration, a Special Edition of STLR focusing on SGBV targeted at women and diverse women will be published. In this regard 10 contributions are currently going through the peer review process.

Between all the hard work, the participating students were also treated to two excursions, hosted by the Township and Village, a community-led organisation, to learn more about Stellenbosch, its communities, and its history. All-in-all, the Faculty hosted a successful event, despite all the challenges the COVID-19 pandemic brought our way. We look forward to next year's event to be hosted by the British University in Egypt.



### Semester Exchange 2021

The Faculty is excited that, after a year of not being able to send students on exchange due to the pandemic and travel restrictions, 22 students are currently at partner institutions abroad. This semester we have students at KU Leuven, Leiden University, Bergen University, Bologna University, EBS Law School (Wiesbaden), Ghent University, Maastricht University, Tilburg University, the University of Amsterdam, Vrije Universiteit Amsterdam, University of Antwerp, University of Bern, University of Helsinki, and Utrecht University.

Academically strong final-year LLB students and students in the general structured LLM programme can participate in a semester exchange, which allows the students to enrol for law modules at our partner institutions, which are then credited towards their SU degree. Students participating in the exchange regularly comment on the incredible learning experience that a semester exchange provides, not only from an academic perspective, but also in respect of personal growth.

Internationalisation is a priority for the Faculty of Law and the semester exchange is one of the avenues through which we realise this strategic goal.

### Law Clinic in the News 2021

# Stellenbosch University Law Clinic successfully opposes class action leave to appeal application.

On 13 September 2019, the Stellenbosch University Law Clinic (the Clinic) filed an application instituting a class action lawsuit with the Western Cape High Court. The Clinic sought the certification of a class action to pursue a claim against Lifestyle Legal for breaching the Consumer Protection Act 68 of 2008 (CPA). The certification application was heard at the Western Cape High Court on 8 and 9 March 2021, with an intervention application from Legal Wise South Africa and Payment Association of South Africa (PASA), before Judge Gamble. The Applicants in the main application argued for an interdict ordering Lifestyle Legal and its affiliated websites from making continuous demands for payment or making unauthorised debits from consumers who may have ac-

cessed the respondents' websites, including consumers who did not seek the services of the respondents. The respondents denied these allegations and contended that the applicants have failed to make a case.

On 21 July 2021, the Western Cape High Court certified the Clinic's class action application. The certification of the class action is significant as it is only the tenth South African class action that has been successfully certified, and it is the first consumer law class action in which the court was required to deliver a certification judgment. It is also the first successful class action certification brought by a South African university Law Clinic.

The respondents appealed the judgment, effectively suspending its immediate impact. The application for leave to appeal was heard on 22 October 2021 before Judge Gamble. On 3 November 2021, Judge Gamble dismissed the application for leave to appeal, with costs, and held that "the respondents have failed to show that they have reasonable prospects, on appeal, of persuading another court to set aside the certification of the applicants' class action."

The certification of this class action enables the Clinic to request restoration of moneys illegally debited, and compensation for the resulting losses on behalf of thousands of consumers who were affected by the respondents' conduct. It also assists to facilitate access to justice for the thousands of vulnerable consumers who have been exploited by the respondents' reprehensible conduct.

# Stellenbosch University Law Clinic successfully defends Ms Phillips and her disabled son in the Supreme Court of Appeal

Ms Clara Phillips approached the Stellenbosch University Law Clinic in July 2009, when she was 73 years old, to oppose the eviction application against her and her disabled son from a property in Somerset West. At that stage, Ms Phillips had been occupying the property for 62 years - since 1947 - when she was just II years old. The property was a part of a much larger farm when she started her residence in 1947. Ms Phillips later married her late husband, who was employed on the farm, and continued to occupy the house. She had been granted a lifelong right of occupation by the previous owner.

In 2009, Mr Grobler lodged an application to evict Ms Phillips and her son. An eviction order was granted against Ms Phillips and her son in August 2016, and they were ordered to vacate the prop-

erty by 30 August 2017. The Clinic successfully assisted Ms Phillips with lodging an appeal against the Magistrate Court's judgment and order at the Western Cape High Court. The appeal was successful, and the High Court set aside the eviction order. An application for special leave to appeal to the Supreme Court of Appeal (SCA) was lodged by Mr Grobler in 2019, with the application granted in June 2020.

Mr Grobler's appeal was dismissed on 14 July 2021, with



all the SCA Justices concurring. Shortly thereafter, the owner applied for leave to appeal to the Constitutional Court against the decision of the SCA. The Clinic served and filed its answering affidavit, on behalf of Ms Phillips, in August 2021. We are currently awaiting the Constitutional Court's judgment or, alternatively, further directives from the Court.

We are hopeful that the outcome at the Constitutional Court will be favourable for Ms Philips and the Clinic.

# **Stellenbosch University Law Clinic** celebrates the launch of the debt, credit, and consumer rights manual

On 27 October 2021, the Stellenbosch University Law Clinic, in collaboration with the Black-Sash Trust and the London School of Economics and Political Science, officially launched the Debit, Credit, and Consumer Rights manual. The manual serves as a reference guide to paralegals, which will empower them with the knowledge to advise their clients on this important area of the law. Two of our attorneys, Odwa Nweba and Josie Parks, attended the virtual launch and provided training on the manual to over 60 paralegals from all over the country.

This comes after, earlier this year, the Clinic was briefed by the prestigious human rights organisation, the BlackSash Trust, to update its then 'Debt and Credit Guide for Paralegals'. The Clinic's staff ensured that this important resource accurately reflects the current legal position. The Clinic will continue to conduct more training sessions.

We are honoured to be part of this initiative and excited to experience its impact.

### Goodman Gallery Centenary Event


