News from the Dean's office

Dear friend of the Faculty

It is a great pleasure to conclude 2022 with a full newsletter, which is testimony to a demanding but fruitful second half of the year.

There are many highlights of the second semester included in this newsletter, including that the year ends with a big international conference (the Global Alliance for Justice Education (GAJE) Conference in partnership with the International Journal of Clinical Legal Education and the South African University Law Clinics Association), which will see around 200 scholars at the Ou Hoofgebou during the week of 12 December. However, the new year will also kick off on a high note on 15 January with another high-profile occasion, namely the Global Scholars Academy that we will be hosting with the Institute for Law and Global Policy, Harvard University. The Academy is an "intensive residential experience designed to enable junior faculty and post-doctoral scholars to engage in sustained, interdisciplinary, peer-to-peer collaboration under the close mentorship of a research faculty drawn from the world's top universities".

It is especially pleasing to reflect on these achievements, activities, and highlights since we aim to be productive rather than just busy, and for this to be the case everyone needs to roll up their sleeves and get things done. Our team continued to do just that the last months, and I thank them for their hard work and dedication this year. As I reminded our final year students in their yearbook, the informal motto at the Faculty is that we support students to become legal practitioners, jurists, and thought leaders. Nangona kunjalo, unyaka omtsha uza kuphinda uqale ngomcimbi obaluleke kakhulu, nge15 kaJanuwari ze kubekho omnye umcimbi okwinganaba eliphezulu, obizwa ngokuba yiGlobal Scholars Academy esiza kube siwusingethe kunye nelnstitute of Law and Global Policy, yeYunivesithi yaseHavard. Geagte vriend van die Fakulteit

Dit is 'n groot plesier om 2022 af te sluit met 'n propvol nuusbrief, wat getuig van 'n veeleisende maar vrugbare tweede helfte van die jaar.

Daar is baie hoogtepunte van die tweede semester in hierdie nuusbrief ingesluit, insluitend dat die jaar afgesluit word met 'n groot internasionale konferensie (die Global Alliance for Justice Education (GAJE)-konferensie in vennootskap met die International Journal of Clinical Legal Education en die South African University Law Clinics Association), wat gedurende die week van 12 Desember ongeveer 200 vakkundiges by die Ou Hoofgebou saam sal bring. Die nuwe jaar sal egter ook op 15 Januarie op 'n hoë noot begin met nog 'n hoëprofielgeleentheid, naamlik die Global Scholars Academy wat ons saam met die Institute for Law and Global Policy, Harvard Universiteit, sal aanbied. Die Akademie is 'n "intensiewe residensiële ervaring wat ontwerp is om junior fakulteit- en nadoktorale akademici in staat te stel om by volgehoue, interdissiplinêre, eweknie-samewerking betrokke te raak onder die noue mentorskap van 'n navorsingsfakulteit wat van die wêreld se beste universiteite bestaan".

Dit is veral aangenaam om oor hierdie prestasies, aktiwiteite en hoogtepunte te bepeins aangesien ons daarna streef om nie net besig te wees nie, maar om ook produktief te wees. Vir dit om die geval te wees, moet almal hul moue oprol en dinge gedoen kry. Ons span het dit die laaste maande voordurend gedoen, en ek bedank hulle vir hul harde werk en toewyding hierdie jaar. Mens moet byvoeg dat om produktief te wees ook duidelikheid oor jou doelwitte vereis sodat jou optrede in lyn is met jou doelwitte en waardes, en ons het hard gewerk om gefokus te bly ten spyte van onstuimige tye.

Soos ek ons finalejaarstudente in hul jaarboek herinner het, is die informele leuse by die Fakulteit dat ons studente ondersteun om regspraktisyns, juriste en denkleiers te word. Op 'n meer formele noot, as Fakulteit streef ons daarna om 'n navorsingsintensiewe fakulteit te wees waar ons uitstaande studente lok, talentvolle personeel in diens neem en 'n wêreldklas omgewing bied: 'n plek wat aan die wêreld verbind is, terwyl ons plaaslike, kontinentale, en globale gemeenskappe verryk. Sentraal tot al hierdie aspirasies is ons studente.

Ek is dus dankbaar dat ons hierdie jaar saam as 'n gemeenskap kon afsluit (insluitend 'n fantastiese gradeplegtigheidsgeleentheid) en dat alle aanwysers op 'n nuwe jaar dui waar studente, personeel en alumni weer aktief aan gesprekke deelneem en by mekaar inskakel op ons pragtige kampus. Persoonlike interaksie en duidelike kommunikasie is immers die sleutel tot 'n gemeenskap waar almal kan groei, leer en uiteindelik kan floreer.

Die Fakulteit, soos die res van US, sal gedurende 2023 deegliker by die Khampepe-verslag betrokke raak, maar een gevolgtrekking is reeds hier ter sake: Regter Khampepe sluit die verslag af deur te sê "die universiteitsgemeenskap mis geleenthede om te kommunikeer, in te skakel en mekaar te verstaan in terme van ooreenkomste eerder as verskille". Ek glo dat die moeilike lesse van 2022 met die nodige introspeksie en oop ingesteldheid die grondslag vir ons kan bied om ons gedeelde waardes, hoop en drome volgende jaar te herbevestig en herkalibreer.

FACULTY OF LAW

The re-focus on research, embarked on in March in the first semester of 2022, continued in the second semester. Given the emphasis on a more "hands-on" approach to research and the need for dedicated research time and space, the Faculty officially returned to the pre-Covid position regarding dedicated research days – one day per week to do research from home; in some instances, an additional research day may also be used.

On 9 and 10 September, members of the Faculty were given the opportunity to immerse themselves in their research and writing at the Faculty's first Writing Retreat, hosted at the Devon Valley Hotel in Stellenbosch. While the retreat was attended by mainly younger scholars – Ms Ebrezia Johnson, Ms Rukshana Parker, Dr Tina Kotzé, Dr Debbie Horsten, Ms Nondo Phenyane, Dr Delano van der Linde, Dr Cecile de Villiers, Dr Jane Diala, and accompanied by Professor Juanita Pienaar – the idea is to expand the initiative in 2023 to include a broad spectrum of scholars and to extend the length of the retreat.

While all participants agreed that it was a huge success, they noted that the programme could be adjusted to include a variety of activities – including some physical activity – to support and enhance the periods spent behind their laptops!

All three departments continued with dedicated research discussion sessions, buzz groups, and even lunchtime lectures. Again, in-person attendance was welcomed by staff and students alike.

The mentoring programme, which was embarked on in the first semester, gained further momentum in the second semester. A new mentoring module was set up on SUNLearn by Ms Alma Coertzen. The module contains a depository of SU documentation and policies relevant to researchers and academics, as well as other useful material and links to interesting and informative podcasts and information. A feedback session is scheduled to take place on 12 December 2022, which will be followed by a well-deserved lunch.

As in the first semester, staff and students were further

involved in a variety of national and international conferences; this undergirds sound research and simultaneously promotes internationalisation. In August, the Labour Law group hosted a very successful conference and book launch in honour of Professor Manfred Weiss. A number of Faculty members, including the Dean, Professor Nicola Smit, contributed to the book, *Liber amicorum: book of friends*.

For the first time in three years, an in-person Southern African Law Teachers Conference took place in East London; the conference was hosted by the Faculty of Law, Fort Hare, from 11 to 15 July 2022. Faculty delegates included Professor Sandy Liebenberg, Professor Geo Quinot, Professor Philip Sutherland, Professor Bradley Slade, Ms Rukshana Parker, Mr Thala Msutu, Ms Ebrezia Johnson, and Professor Juanita Pienaar.

of the NRF-funded South African Research Chair in Property Law – Transforming Property Law, from 30 November to 2 December 2022, organised by Professor Zsa-Zsa Boggenpoel and an international Social Justice Education Conference, scheduled to take place in hybridformat from 11 to 15 December 2022, under the auspices of the SU Law Clinic.

A follow-up session linked to research and post-graduate studies was held on 19 July 2022 where other channels to gain access to postgraduate studies, including a preparation-module, were explored, under the guidance of Mr Shirle Cornelissen and Ms Cindy de Doncker. The session also dealt with the supervisor's role and corresponding duties and responsibilities, as well as providing information on the new cycle of examination of postgraduate students under the 2022-Postgraduate Guide, presented by Ms Silke de Lange. The prep-module initiative was taken further by the Research Committee in October 2022 and finalised by the Faculty Board in November 2022. From 2023, there will thus be three options to gain access to postgraduate studies: the socalled 'short procedure'; registration after completion of a research proposal accepted at the Faculty Board; and the new procedure, the preparation-module for LLM and LLD respectively.

The research re-focus initiative will continue in 2023. A Faculty-wide Research Indaba is scheduled to take place on Monday, 30 January 2023.

Law Teachers Conference

Internationalisation



The Faculty's Internationalisation Committee continued regular meetings, which feed into the overarching Institutional Advisory Committee on Internationalisation (IACIA) under the auspices of Professor Hester Kloppers.

The Vice-Dean: Teaching & Learning, Professor Richard Stevens, was invited by the Technische Universität München (TUM) participate to in the Global Visiting Professor Programme. Whilst abroad, Professor Stevens also visited two partner faculties of the Faculty, the Bucerius Law School in Hamburg and the Tilburg Law School in the Netherlands, which is ranked by Times Higher Education as the 21st best

law school in the world. Professor Stevens also visited the Münster Law Faculty, where Professor Petra Pohlman, Dean of the Faculty of Law, signed the long-awaited exchange agreement between the Münster Law Faculty and SU Faculty of Law. The exchange agreement enables up to two staff members from the partner universities to visit the other university and present short courses on specific research focus areas. The first exchanges will take place in 2023.

Another exciting development within the internationalisation domain is a student exchange agreement that was concluded between the Faculties of Law of SU and the University of Cambridge. The agreement enables up to two students to spend an academic year at the partner institution as a visiting student. At Cambridge, the visiting students will have the opportunity to choose any of the undergraduate law papers offered by the Faculty of Law. They will also be members of one of the 31 colleges and receive supervisions in their chosen papers. At Stellenbosch, the visiting students will be able to choose from both undergraduate and certain postgraduate law papers offered by the Faculty of Law.

Associate Professor, Felix Steffek, the Director of International Strategy and Partnerships at Cambridge said: "The exchange with Stellenbosch University is an exciting opportunity for our students as it opens a pathway to studying law at one of the leading universities in Africa. We are very much looking forward to welcoming the first visiting students from Stellenbosch in the 2023-2024 academic year."

Professor Mark Elliott, Chair of the Faculty of Law at Cambridge, said: "I am delighted that we are partnering with Stellenbosch University in this, and that Cambridge and Stellenbosch students will have the rich intellectual and cultural opportunities that this exchange programme offers. I am grateful to our former Director of International Strategy and Partnerships, Professor Jens Scherpe, for bringing this project to fruition, and we look forward greatly to welcoming our first students from Stellenbosch next year."

Staff and student exchanges in the second semester also included an internship at the Law Clinic of a number of students from Hasselt University in the period 21 July to 19 August 2022. The visit coincided with a lunchtime seminar on 28 July 2022 presented by Dr Matteo Fermeglia on the topic of "Climate change responsibility and liability: EU and South African perspectives". The event was co-hosted with Professor Olivier Ruppel.

Another visit under the auspices of the SU Law Clinic, by student representatives and staff members of Strathmore University Law Clinic, took place in the week of 10 to 14 October 2022. While the aim was to gain knowledge and insight into the running of the SU law Clinic, the student representatives also presented their initial research findings during a lunchtime seminar on Thursday, 14 October, with a view on the December-conference in Stellenbosch, which is mentioned above.

Teaching and Learning

It would be remiss not to mention that the academic year started off with restrictions on gatherings still in place and not being able to have all students back in class. Finishing the year with full classes certainly has been an enriching experience for staff and students alike and results have seemingly also improved.

Our mid-year newsletter highlighted the roll-out of the new first-year modules. We can report that the roll-out of Law of Persons in the second semester proceeded smoothly. We will take stock of the positives and negatives of the first-year modules before the end of the year to make improvements, where necessary, for 2023. The purpose of this stock-taking session is twofold. Firstly, we want to ensure that the first-year modules are aligned to ensure that studen opportunity ts are alive to the fact that the law does not operate in silos but that what happens in one module has an impact on other modules. Secondly, this stock-taking session will also include the second-year modules that are being rolled out in 2023. Again, we want to ensure that modules are horizontally and vertically aligned. This is to ensure that students are always alive to the fact that what they learned in their first year builds up vertically in succeeding years.

A review of assessment has taken place on a universitywide basis in 2022. Essentially, faculties will have more freedom in the future on how to assess students. Extensive consultation and workshops have taken place and continue to take place within the Faculty of Law to ensure that we assess students in a variety of ways to ensure that the skills and competencies that we, and the workplace, expect of our students are assessed. This is an ongoing project with sufficient flexibility that enables the Faculty to adapt its assessment rules annually. We are excited what this opportunity enables us to do - it allows us to assess content as well as the critical skills that our students require irrespective of which career they choose. Assessment was also the focus of the 2022 Scholarship of Teaching and Learning Conference from 24 to 26 October 2022. This conference is open to academics from Stellenbosch University who have an interest in the scholarship of Teaching and Learning. The theme for this year's conference was "Re-imagining assessment culture and practices for a transformative student experience". In light of the Faculty's journey to adopt its renewed LLB and the concomitant focus on assessment, Professor Stevens and Dr Greenhalgh participated in the conference; Professor Stevens was a keynote panellist and Dr Greenhalgh presented a paper.

Therefore, from a Teaching and Learning perspective, we are grateful that we could conclude the academic year with students back in the classroom and in-person invigilated end-of-year assessments; we are also grateful that the roll-out of new modules in the first year went smoothly.

African Procurement Law Unit (APLU)



APLU hosts UNCITRAL Days in Africa seminar

APLU collaborated with the United Nations Commission on International Trade Law (UNCITRAL) to host a public seminar on public procurement dimensions of modernising and harmonising the international commerciallaw framework in the African Continental Free Trade Area (AfCFTA) context. The seminar formed part of the UNCITRAL Days in Africa academic series, which aims to celebrate the establishment of UNCITRAL and to raise awareness of the work of UNCITRAL in promoting the progressive harmonisation and modernisation of international trade and commercial law throughout the continent. The seminar focused specifically on public procurement law within international trade law regimes, with a particular focus on the African Continental Free Trade Agreement. Participants considered the current levels of procurement law harmonisation in Africa as well as the advantages, disadvantages, and potential modalities of a truly continental project of procurement law harmonisation in Africa. Speakers included Caroline Nicholas and Benjamin Herisset of UNCITRAL; Professor Sope Williams and Professor Geo Quinot of APLU; Professor Christopher Yukins of the George Washington University School of Law; and Dr Dominic Dagbanja of the University of Western Australia (and also an APLU research fellow).



Workshop on Public Procurement Authorities

APLU, in collaboration with Crown Agents and the Open Contracting Partnership, hosted an open online workshop to discuss one of the recommendations on public procurement reform in South Africa. The recommendation, which was put forward by the Judicial Commission of Inquiry into State Capture (the Zondo Commission), is the creation of a Public Procurement Anti-Corruption Agency.

In brief, the Commission recommended:

"In the view of the Commission and for the reasons that follow, the appropriate starting point for any scheme of reform must include the establishment of a single, multi-functional, properly resourced, and independent anti-corruption authority with a mandate to confront the abuses inherent in the present system. That authority could be called the Anti-Corruption Authority or Agency of SA South Africa (ACASA)." Judicial Commission of Inquiry into State Capture Report Part 1 (2022) par 664

This recommendation follows the proposal put forward in the draft Public Procurement Bill, published in 2020, for the creation of a Public Procurement Regulator.

Many other countries on the African continent and

beyond have created public procurement authorities of various types. These provide rich experiences for South Africa to look at when considering the creation of a procurement authority of some sort.

This workshop hosted leaders from existing procurement authorities in Kenya, Ghana, and Chile to share their experiences in setting up and running such entities. Speakers included Mr Patrick K. Wanjuki, Director-General, Public Procurement Regulatory Authority of Kenya; Ms Faith Waigwa, Chairperson of the Public Procurement Administrative Review Board of Kenya; Ms Tania Perich Iglesias Director, Dirección ChileCompra, Chile; Mr. Frank Mante, Chief Executive Officer, Public Procurement Authority, Ghana; Mr Steve Guppy of Crown Agents; Ms Caroline James of the Open Contracting Partnership and Professor Geo Quinot of APLU. It also created an opportunity for discussing the proposals put forward to create such an entity in South Africa. More than 200 participants joined the workshop. APLU contributes to major international public procurement conference

In June, APLU collaborated with the Public Procurement Research Group at Nottingham University in hosting the leading international conference on public procurement law, Public Procurement: Global Revolutions XI in Nottingham, UK. At the conference, Professor Sope Williams of APLU shared perspectives from Africa on the new frontiers in procurement during the opening plenary session and presented a paper on gender inclusive procurement in Africa in a session focusing on gender equality, diversity, and social inclusion in public procurement. Professor Geo Quinot presented a paper on the UNCITRAL Model Law on Public Procurement in a session focusing on procurement law reforms in Africa and participated in a session that presented the findings of a major international study on the human rights dimension of sustainable public procurement of infrastructure. The conference was codirected by APLU research fellow, Professor Annamaria la Chimia.

Contributing to public procurement law reform in South Africa

Professor Geo Quinot served as a member of a joint strategic resource to NEDLAC on public procurement law reform. The long-awaited complete overhaul of public procurement law in South Africa was deliberated on by a NEDLAC task team following the government's submission of a draft Public Procurement Bill to NEDLAC in April 2022. The joint strategic resource consisted of five experts in various aspects of public procurement and provided the NEDLAC task team with technical assistance in its discussions of the draft Bill. Following the completion of the NEDLAC review, the Bill is due to be submitted to Cabinet towards the end of 2022 and is expected to be tabled in Parliament by March 2023.



Perspective series webinar UFS Centre for Human Rights

Professor Sandra Liebenberg was hosted by the Director of the University of the Free State's Centre for Human Rights, Professor Danie Brand, for a webinar discussion during the centre's perspective series on 26 May 2022. Professor Liebenberg addressed the attendees on "Impoverishment, inequality, and Human Rights". During her address, Professor Liebenberg

indicated that a scarcity of available resources is not an automatic justification for not addressing human rights violations in the form of fiscal injustice. Professors Liebenberg and Brand indicated that the realisation of rights through resource mobilisation and redistribution would need transformative politics in the fiscal arena. Professor Liebenberg also argued that although courts are institutionally restrained, they are tasked to hold, at the very least, the other branches of government accountable "to come up with a credible plan of action, in consultation and with the participation of society, on how they are going to close the inequality gap." Academic staff, civil society organisation representatives, media houses, and students from across South Africa attended the webinar. A write-up of the webinar can be accessed here.

Transformation workshop on intersectionality

The Transformation Committee of the Law Faculty under the leadership of Professor Zsa-Zsa Boggenpoel, with the support of the HF Oppenheimer Chair in Human Rights Law, hosted a workshop for staff with the theme "Embedding intersectional discrimination as an educational practice" on 4 August 2022. The workshop was co-presented and facilitated by Ijeoma Opara from the SARCHi in Gender Politics at Stellenbosch University and Gideon Basson from the HF Oppenheimer Chair in Human Rights Law. Although the workshop was not well-attended by all staff members, the attendees shared personal and difficult experiences of intersectional discrimination within the higher education setting. The facilitators offered the attendees an "Intersectionality Wheel of Power and Privilege: As observed in Stellenbosch", together with an empty wheel of intersections, where participants discussed multiple layers and intersecting forms of disadvantage that inhibit their educational role as learners or educators. The attendees also explored innovative practices to challenge intersectional disadvantages within and through their

Non-nationals' rights to health care

Respected constitutional lawyers speak out — 'human right to healthcare transcends national borders'

Mr Gideon Basson and Professor Sandra Liebenberg published a significant human rights op-ed in Daily Maverick Citizen of 8 September on the rights to health care of nonnationals under the South African Constitution in light of the troubling events of discriminatory exclusions of non-nationals from various primary care facilities across the country. The authors indicated that the current legislative and policy frameworks for regulating nonnationals' access to healthcare services are a patchwork of provisions that are not well aligned with the human right to health in the Constitution and international human rights law. In addition, they stressed that a coordinated and human rights-informed policy and legislative framework are urgently required to give effect to the right of nonnationals to health care services.

NRF awards ceremony

On 1 September 2022, Professor Sandra Liebenberg attended the 2022 NRF Awards Ceremony at the Century City Conference Centre, Cape Town, where she received her award for her first NRF A-rating.

First human rights postgraduate seminar

On the 7th of September 2022, the HF Oppenheimer Chair in Human Rights Law and the Department of Public Law presented its first Human Rights Postgraduate Seminar. The seminar was organised by LLD candidate, Christiaan van Schalkwyk and assisted by Claire Rankin and Sharnelle Paulse, LLM candidates at the HF Oppenheimer Chair in Human Rights Law.

The seminar was opened to postgraduate LLM students, LLD candidates, and post-doctoral candidates with human rights-focused research projects. Its aim was to give postgraduate students an opportunity to present their research in a conference-type environment and to receive feedback from their peers and lecturers in the Department of Public Law. It also served to facilitate intellectual engagement on human rights themes and to build a sense of community amongst postgraduate students and staff. Students presented on a variety of human rights issues, including the right to education; land and housing rights; the African regional human rights system; gender equality; socio-economic and environmental rights; oversight in procurement and budgetary allocations; and animal rights.

It was the first time since the Covid 19-pandemic that postgraduate students had an opportunity to interact with each other's research in person. The seminar was held at The Silo and Shed, a rustic conference venue located at Fransmanksraal Farm, just outside Stellenbosch.

Research impact: Discrimination on the basis of socio-economic disadvantage recognised

The recent report of the Special Rapporteur on Extreme Poverty and Human Rights of the United Nations Human Rights Council with the title, "Banning discrimination on grounds of socio-economic disadvantage: An essential tool in the fight against poverty" was broadcasted on 13 July 2022 and presented to the General Assembly on 28 October 2022. The report recognises the work of Professor Sandra Liebenberg, Mr Gideon Basson and Dr Delano van Der Linde in this field. Professor Liebenberg and Mr Basson also assisted the special rapporteur in the final stages of the report. In his report, the special rapporteur, Professor Olivier De Schutter, discusses how discrimination against people in poverty operates and how it can be addressed. He argues that anti-discrimination frameworks should be strengthened to effectively prohibit discrimination on the grounds of socioeconomic disadvantage.

Expert seminar on Sustainable Development and Economic, Social and Cultural Rights and Meeting of the Drafting Group of the Principles and Guidelines of the Human Rights of Future Generations

Professor Sandra Liebenberg travelled to Geneva during the first week of October 2022 for two engagements. The first was an Expert Seminar held on 1 October 2022 on sustainable development and economic, social, and cultural rights. It was hosted by the UN Committee on Economic, Social, and Cultural Rights ("UN CESCR") together with the German Institute for Human Rights and the Friedrich Ebert Stiftung. Professor Liebenberg presented the opening address entitled "Sustainable development and economic, social, and cultural rights: The state of art". Former doctoral candidate in the HF Oppenheimer Chair, Dr Megan Donald, also presented a paper at the seminar on the key outcomes of the regional and thematic consultations hosted by the UN CESCR on a proposed new General Comment on the theme of sustainable development and economic, social, and cultural rights.

Thereafter, Professor Liebenberg participated in a virtual consultation held on 4 October 2022 and chaired an inperson meeting of the Drafting Group of the *Principles and Guidelines on the Human Rights of Future Generations*. The latter took place from 4 to 6 October at the Maison Internationale des Associations in Geneva. The Principles and Guidelines on the Human Rights of Future Generations will be adopted at a conference hosted by Maastricht University's Centre for Human Rights in early February 2023.



Centre for Social Justice

October was a busy month for the Law Trust Chair in Social Justice at Stellenbosch University (SU). On 11 and 12 October, the Annual Social Justice Summit and International Conference on restitution were held at Boschendal and it coincided with the launch of the SU Faculty of Law's brand-new Centre for Social Justice (CSJ).

At the reception on 11 October, the Dean of the Law Faculty, Professor Nicola Smit, announced Professor Thuli Madonsela, until now the Law Trust Chair in Social Justice, as the inaugural director of the CSJ. Professor Smit explained the mission of the CSJ in the context of the university's transformation and restitution initiatives. "The mission of the new Centre for Social Justice is to promote social justice scholarship and consciousness, public policy design skills, and collaboration in academia and society," Professor Smit said.

Professor Smit added that the CSJ will be rooted in collaboration, both academically and in terms of social impact: "The Centre for Social Justice is an academic and research entity that resides within the Faculty of Law, but its constitution explicitly acknowledges the importance of working across the different faculties of the university, other higher education institutions, as well as public and private, local, and international enterprises and stakeholders."

In her inaugural speech as the newly appointed director of the CSJ, Professor Madonsela expressed gratitude for the opportunity to expand and strengthen the social justice initiatives she has spearheaded as the Law Trust Chair over the past five years. She also thanked all stakeholders for journeying with her and her team on the quest to accelerate the pace of responding to the constitutional call to establish a peaceful society that is based on social justice. "The Centre will house all academic programmes and social impact projects currently undertaken by the Law Trust Chair in Social Justice. It will also be the entity through which all future academic scholarship and social impact projects of the Law Trust Chair are undertaken," Professor Madonsela explained.

At the reception the newly-appointed SU Vice Chancellor for Research and Innovation, Professor Sibusiso Moyo, also commented on the link between the establishment of the CSJ and the university's approach to transformation. She said the CSJ flows from the new Strategic Plan of the University where it seeks to use its academic spaces and partnerships for research and innovations that offer solutions to the continent's pressing challenges while being a force for positive change to advance social justice.

Even if it sometimes involves collaboration between researchers from different faculties, the CSJ is a Type 2 academic entity that reports to a single faculty. Such an entity can be established if its activities are significantly interdisciplinary or transdisciplinary in nature. A Type 2 entity may use the nomenclature of 'centre', 'institute', or 'school' and has a primary link to a single host faculty. The Centre will continue with collaborations with researchers in data science and serious gaming in a quest to reduce inequality through impact-conscious policymaking. The flagship project of the Centre remains the Musa Plan for Social Justice, which aims to mobilise societal, corporate, and international support and resources toward the accelerated reduction of poverty and inequality.

Professor Madonsela visits the UK

In September, Professor Thuli Madonsela joined the Development and Alumni Relations Office in visiting various constituents in the United Kingdom.

When Professor Madonsela was asked about her thoughts on talking about social justice to a UK community, Professor Madonsela said, "I am looking forward to speaking in the UK and engaging with the UK community on the topic of social justice. In this fast-moving world, most societies and political regimes, including those founded on democratic principles and ideals, struggle to achieve and maintain a balance between individual freedom and social justice. As we face increased economic and social pressures, inequality is expanding across all societies and so the need for social justice strengthens, and we must come together to find solutions."

The visit included a Social Walk to discuss Action4Inclusion and Social Justice, and a business breakfast hosted by Freshfields Bruckhaus Deringer LLP at the SA Chamber of Commerce, which presented Professor Madonsela with the opportunity to engage with the in-person and online audience around the topic of "What is Social Justice?"; and an intimate lunch with donors of Stellenbosch University and Trustees of the SU Foundation in the UK, where the conversation was around the work of the newly launched Centre for Social Justice. As a guest of Professor Adam Habib, Professor Madonsela gave a public lecture in the Brunei Gallery as part of the Director's Lecture Series to guests of SOAS and SU alumni living in London. The lecture, "The Meaning of Social Justice", is available here. Professor Madonsela's visit ended in Edinburgh as a guest of the Society of Writers to His Majesty's Signet (known as the WS Society). The event hosted by the WS Society was preceded by a Q&A session where a group of young law graduate interns were given the opportunity to interact with Professor Madonsela. The welcome address was delivered by Lady Dorian, a Scottish advocate and judge who has served as the Lord Justice Clerk since 2016. Thereafter, Professor Madonsela engaged with acclaimed international journalist, Meera Selva, about the role of media and the law fraternity in ensuring the safeguards of democracy and social justice.

OYW is co-founded by former South African, Kate Robertson; it is a platform for young leaders from all continents and diverse communities to present on and talk about what they are doing to fix problems they have identified that are standing in the way of becoming the community they want to be.

The summit convened the brightest young talent from every country and sector, who are working to accelerate social impact. Delegates from 190+ countries were counselled by influential political, business, and humanitarian leaders, including Professor Madonsela and the Duke and Duchess of Sussex, Meghan Markle and Prince Harry.

One of Professor Madonsela's many speaking engagements at the Summit included Strengthening Democracy as well as Ethical leadership. Professor Madonsela was also virtually linked to the Johannesburg Hive platforms; the participants of the event were engrossed with Professor Madonsela's keynote addresses. On the last day of the Summit, the news of the passing of Queen Elizabeth II exposed delegates to another remarkable demonstration of the innovation, agility, and resilience of young leaders. When the news of the queen's passing reached conference organisers, it included a protocol requiring all events to cease. This meant excising the Olympics-styled ceremony where the mayor of Manchester passes the baton to the next host



city, which is Belfast.

The participants, who hail from as far as Mauritius and Botswana, have warmly embraced the courses, with a multidisciplinary team of presenters that includes a Harvard Professor and colleagues from SU.

Counter-Corruption Summit

From the first session it was clear that the conference would be a dynamic space, where there would be opportunity for deep reflection on the past, analysis of the present and planning for the future. Notably, Professor Sibusiso Moyo, the Deputy Vice-Chancellor: Research, Innovation and Postgraduate Studies at Stellenbosch University, encouraged the delegates to be forward looking in their engagement.

Similar themes arose from the keynote address by Justice Johan Froneman, who challenged delegates to think of practical next steps for land reform while keeping in mind that history remains important to how we formulate future strategies.

Professor Boggenpoel reflected on the networks formed through the existence of the Chair, remarking on the transformative nature and potential of many of these collaborations. The extraordinary track record of publications from the SARCPL was highlighted, with special reference to the successful Property Law Library Series (published by Juta) that, at the end of 2022, consists of 15 volumes, with growth of the library expected in coming years.


The conference also included a surprise panel, where Professor Danie Brand, Professor Rashmi Dyal-Chand,

A new book in the Juta Property Law Library series, entitled Property Regulation: An integrated approach under the Constitution, by Dr Elsabé van der Sijde was launched at the South African Property Law Teachers Colloquium, hosted by North-West University on 10 November 2022. and Professor Elmien du Plessis reflected in a somewhat less academic fashion on the most pressing problems in property law that demand attention in the next 15 years, which also aimed to serve as an inspiration for the next generation of scholars.

The conference also included two special social evening events. On 30 November, the SARCPL and Juta hosted a book launch for an alumna of the Chair, Dr Elsabé van der Sijde, whose book Property regulation: An integrated approach under the Constitution had recently been published. On 1 December, a gala dinner was hosted at STIAS where delegates could continue the discussions of the day while enjoying South African (Stellenbosch University) hospitality.

The conference concluded on Friday 2 December with academic friendships strengthened, new connections made, and renewed enthusiasm and dedication to the important work of ensuring that property law can play a meaningful role in creating a more just and equal society.

Faculty of Law self-evaluation 2019 to 2021: Quality is everyone's responsibility

As required by the SU Policy for Quality Assurance and Enhancement, the Faculty of Law underwent a selfevaluation from 19 to 21 October. This was the first time that the Faculty was evaluated as a whole rather than its distinct components (i.e., the three departments and the SU Law Clinic). The Faculty (with inputs from staff, students, and Faculty leaders) prepared a comprehensive self-evaluation report with a portfolio of evidence over the course of almost a year, and this self-evaluation report formed the basis for four external academics from other national law faculties to reflect and report on the Faculty's self-evaluation.

During the site visit from 19 to 21 October, the panel not

only had the opportunity to see our facilities but also interviewed administrative, professional, and academic staff. The panel also interviewed undergraduate and postgraduate students. The Faculty has already addressed some of the areas that we self-identified for improvement, and we look forward to receiving the panel's final report and recommendations.

The first part of the formal process has, therefore, now been completed and will only be repeated after a six-year cycle. However, we believe that quality is more than a promise, it involves genuine and consistent performance and, therefore, quality assurance is something with which we will continually engage.

Fakulteit Regsgeleerdheid selfevaluering 2019 tot 2021: Kwaliteit is almal se verantwoordelikheid

Soos vereis deur die US Beleid vir Gehalteversekering en Verbetering, het die Fakulteit Regsgeleerdheid vanaf 19 tot 21 Oktober 'n selfevaluering ondergaan. Dit was die eerste keer dat die Fakulteit as geheel 'n selfevaluering ondergaan het eerder as sy afsonderlike komponente (d.w.s. die drie departemente en die US Regskliniek). Die Fakulteit (met insette van personeel, studente en fakulteitsleiers) het oor die loop van byna 'n jaar 'n omvattende selfevalueringsverslag met 'n portefeulje van bewyse opgestel. Hierdie selfevalueringsverslag het die basis gevorm vir vier eksterne akademici van ander nasionale regsfakulteite om oor die Fakulteit se selfevaluering te besin en verslag te lewer.

Tydens die besoek van 19 tot 21 Oktober, het die paneel nie

net die geleentheid gehad om ons fasiliteite te sien nie, maar ook om onderhoude te voer met administratiewe, professionele en akademiese personeel. Die paneel het ook onderhoude gevoer met voorgraadse en nagraadse studente. Die Fakulteit het reeds sommige van die areas wat ons self geïdentifiseer het vir verbetering aangespreek, en ons sien uit daarna om die paneel se finale verslag en aanbevelings te ontvang.

Die eerste deel van die formele proses is dus nou afgehandel en sal eers na 'n sesjaarsiklus herhaal word. Ons glo egter dat kwaliteit meer as 'n belofte is, dit behels opregte en konsekwente prestasie en daarom is kwaliteitsversekering iets waarmee ons voortdurend besig sal wees.

Criminal Justice Winter School

The Criminal Justice Winter School took place on 27 and 28 June and provided postgraduate LLM and LLD students with the opportunity to present their research, in various stages of completion, to subject-experts. The Winter School was held online and was co-organised by Stellenbosch University (Professor Shannon Hoctor) and University of Cape Town (Dr Tshepo Mosaka). Emeritus Professor Jonathan Burchell delivered the opening address titled "South African criminal justice still at the crossroads". Dr Mary Nel and Dr Delano van der Linde also served as a chair and discussant, respectively, during two of the sessions.

From SU, Ms Kirstin Hagglund discussed her comparative study on *dolus eventualis* while Mr Enrico Meyer discussed his research on the publication of criminal proceedings in South Africa. Both participants from SU were runners-up for the best speaker prize.

Certificate Programme in Labour Dispute Resolution Practice (CLDRP)

For the past eight years, Professor Christoph Garbers has presented the Certificate Programme in Labour Dispute Resolution Practice (CLDRP), in collaboration with the Commission for Conciliation, Mediation and Arbitration (CCMA), in Stellenbosch and Midrand. Designed to train participants for a career as a commissioner of the CCMA, the programme has, over the years, attracted more than 1 500 students, delivered around 900 successful participants, and delivered (more than all other universities combined) the greatest number of successful applicants for positions as CCMA commissioners. In 2022, for the first time since 2019, the programme was again offered in person, with Stellenbosch University the only one to do so from all the universities involved in this initiative.

Colloquium

On 2 to 3 September, the Faculty hosted a Labour Law Colloquium at the Stellenbosch Institute for Advanced Study, which brought the South African labour law community together in person for the first time after the pandemic. Titled "Labour Law: Past, Present and Future", the colloquium formed part of the Faculty's centenary celebrations and also served as a vehicle to honour the contribution of Professor Manfred Weiss (Professor Emeritus, Goethe University, Frankfurt) to South African labour law. Professor Weiss was one of the drafters of the South African Labour Relations Act and has been a regular visitor to South Africa over the past 30 years, sharing his knowledge and experience with academics and students alike. The keynote address at the colloquium was delivered by Professor Simon Deakin from Cambridge University, who spoke on the crisis and revival of labour law from an international perspective. Other visiting speakers included Judge Basheer Waglay (Judge President of the Labour and Labour Appeal Court); Professor Evance Kalula (UCT); Judge Andre van Niekerk (Judge of the Labour Court); Professor Cameron Morajane (Director of the CCMA); Judge Avinash Govindjee (Judge of the High Court); Professor Letlhokwa

Mpedi (Vice Principal, and Principal designate, University of Johannesburg); Dr Ockert Dupper (International Labour Organisation); and, of course, Professor Weiss himself. Members of the Faculty who participated in the proceedings include Professors Nicola Smit, Christoph Garbers, Thuli Madonsela, and Karin Calitz, while one of the Faculty's doctoral students – Ms Riana Conradie – had the opportunity to speak about her research into neurodiversity in the workplace. At a dinner for delegates at Glenelly Estate on Friday, 2 September, the Liber Amicorum: Manfred Weiss (a book written in honour of Professor Weiss, co-edited by Professor Smit and to which a number of Faculty members contributed) was launched and dedicated to Professor Weiss and his contribution to labour law and scholarship.

Regional Learning and Teaching Conference

The Regional Learning and Teaching Conference, which took place on 8 September 2022, provided students (undergraduate and postgraduate) and staff members with a wonderful opportunity to meet with colleagues from the University of Cape Town (UCT) and the University of the Western Cape (UWC) on core issues and opportunities that arose during the Covid-19 pandemic. For example, using online resources to aid learning and teaching (such as, SUNLearn, the University's online platform), including the positives and negatives. However, this conference highlighted that the same critical issues and opportunities were experienced, irrespective of where one studied or taught.

It was a fascinating opportunity to hear from other universities, especially what their approaches were to online learning during the Covid-19 pandemic. Some immersed themselves in the online space and some missed the face-to-face lectures where they could easily engage with students. It was a great opportunity to hear from students regarding their experiences during the Covid-19 pandemic and how they coped with moving learning and teaching online. This discussion aided teaching staff, teaching assistants and lecturers alike, to understand and develop the skills to adjust the old way of doing things to address the needs of the students (which was echoed by colleagues from the other universities). At Stellenbosch, this was quite an important point that was raised especially since there is an all-inclusive Extended Learning Space (ELS) system in place in most classrooms, which aids new ways of teaching.

The disruption caused by Covid-19 gave teaching assistants and lecturers the valuable opportunity to take a step back and reassess how law is taught to students (both undergraduate and postgraduate). This conference was a valuable step towards implementing the product of such introspection and to build on it in the years to come.

Ms Gretchen Adams and Mr Ernst Heydenrych (LLD candidates) report that: "It was a privilege for us to present our experiences during 2020 and 2021 as teaching assistants since it was a new world to us too. It was a rewarding journey to engage with our fellow assistants, and teaching staff to assist them in any way possible. It presented us with the opportunity to develop our skills and assist our colleagues in achieving their potential (be that on using resources on SUNLearn or teaching online). It also gave us a renewed sense of patience, and diligence, which we would not take back." They also extended their thanks to Mrs Ebrezia Johnson for inviting them to present and to be part of the conference.

South African Society for Labour Law (SASLAW) Conference

The South African Society for Labour Law (SASLAW) celebrated a milestone this year when it hosted its 25th annual conference on 6 and 7 October 2022 in Sandton, Johannesburg. Professor Christoph Garbers and Dr Cecile de Villiers jointly represented the Faculty at the conference. Professor Garbers spoke about misconduct in the public service in general, while Dr de Villiers focused on the rather disturbing picture around misconduct of educators employed in the public education sector (this was part of her research for the doctoral degree conferred on her earlier this year by Stellenbosch University). A particularly exciting development around the conference was that Professor Garbers and Dr de Villiers were accompanied by a group of ten pre-final year students of the Faculty

As one of the students remarked afterwards: "A number of times issues relating to those discussed at the SASLAW conference, and between those of us who attended, have come to my mind with relevance to both my legal studies and to a broader worldview generally. It was a thoroughly enriching experience, not only through the official programme, but through the exposure it gave us to the legal field and community in general. I feel enormously privileged to have been included."

Symposium in honour of Reinhard Zimmermann

From 13 to 14 October 2022, Professors Jacques du Plessis and Philip Sutherland participated in a symposium honouring the retirement of Professor Reinhard Zimmermann as Director of the worldrenowned Max Planck Institute for Comparative and International Private Law in Hamburg, Germany. The theme of the symposium was "Comparative Legal History and Historical Comparative Law". Professor du Plessis also chaired one of the sessions on the German and English law of unjustified enrichment. The symposium culminated in the handing over of a copy of a collection of essays dedicated to Professor Zimmermann on his 70th birthday. Three of these contributions were by Stellenbosch colleagues: Professor du Plessis wrote on "Basic Features and Problems of the South African Law of Unjustified Enrichment", whereas Dr Franziska Myburgh's contribution was titled "Setting the Record Straight: The 'South Africanisation' of the Prior Common Intention Requirement for the Rectification of Contracts". It is sad, yet touching, that our late colleague Professor Marius de Waal posthumously honoured his close friend, Professor Zimmermann, with the last product of his academic career, an essay on "The Flexibility of the Ownership Concept in the Law of Trusts". For more

than three decades, Professor Zimmermann has been a great benefactor of the Law Faculty; he has invited many colleagues to contribute to various international projects, hosted colleagues and students as visitors to the Institute, and engaged with the Faculty as an honorary professor in the Department of Private Law, and by presenting the Morti Malherbe lecture. In 2008, Stellenbosch University awarded him an honorary doctorate in law, one of ten he has received over his remarkable career.

Annual Regional Africa Human Rights Academic Network Conference

From 28 to 29 October, Professor Annika Rudman, together with Ms Anisa Mahmoudi (LLD candidate), Mr Derick de Klerk (LLM Candidate), and Mr Gideon Basson (former LLM Candidate and part-time lecturer), participated in the *Annual Regional Africa Human Rights Academic Network Conference* on the theme *Human Rights Adjudication in Africa: Challenges and Opportunities within the African Regional and Sub-Regional Human Rights Systems.*

The conference was organised by the Raoul Wallenberg Institute of Human Rights and Humanitarian Law, Lund, Sweden, the Faculty of Law, University of Zimbabwe, and the Regional Africa Human Rights Academic Network, of which SU Law Faculty is a member. The conference was supported by the Swedish International Development Cooperation Agency (Sida) and the Swedish Embassy in Harare.

The conference was held at a time when the space for defending human rights in Zimbabwe is rapidly shrinking and the focus on the importance of supranational human rights institutions could not have been more apt.

On day one, Mr de Klerk presented a paper that he coauthored with Professor Rudman titled, "The ultimate withdrawal: a critical analysis of the jurisprudence of the African Court on Human and Peoples' Rights in search of explanations beyond the political". Day two started off with a panel on *Gender-sensitive Adjudication in Africa* where Professor Rudman presented her paper on "Rape as manifestation of gender-based discrimination - an exploration of state responsibility for sexual and gender-based violence in the jurisprudence of the ECOWAS Community Court of Justice" followed by Ms Mahmoudi and Professor Rudman's paper, "A Critical Analysis of Resocialisation as an Obligation, Right and Remedy under the Maputo Protocol in the Jurisprudence of The African Court on Human and Peoples' Rights and The ECOWAS Court of Justice". These presentations were followed, in the afternoon, by Mr Basson's presentation on "Fortune as a ground of prohibited discrimination under the African Charter on Human and Peoples' Rights".

The conference was preceded by a three-day workshop held in Nairobi Kenya in June to support early career researchers in their first endeavour to publish their academic work. The research emanating from this conference will be published in a book in early 2023 by PULP. As a result of the workshop and the hard work of the early career researchers 8 out of the 16 chapters of the book have been produced by up-and-coming researchers.

Next year's Annual Regional Africa Human Rights Academic Network Conference will be hosted by the Faculty with the hope that as many colleagues as possible will feel inspired to participate.

Professor Quinot is currently on sabbatical leave and presented papers at two virtual conferences during the second half of 2022. In October, he read a paper on "Peculiarity and generality in South African procurement law as barriers and enablers of BRICS procurement law congruence" at the St Petersburg International Contractual Relations Forum. At the International Exchange Forum on Sustainable Public Food Procurement, hosted by the UN's Food and Agriculture Organization (FAO) and the German Institute of Development and Sustainability (IDOS), Professor Quinot presented a paper on "Procurement regulation for sustainable public food procurement". In November, Professor Quinot participated in the 23rd International Conference of Chief Justices of the World on Article 51 of the Constitution of India, held in Lucknow, India, which focused on sustainability in effective global governance.

Professor Geo Quinot joined Dr Eugenio Vaccari of the University of London and Professor Laura Coordes of the University of Arizona in the first instalment of a new series of INSOL Talks, called "Hot Topic discussions", focusing on leading topics within the global insolvency community. The first episode focused on Local Public Entities in Distress and reflected on a global study, funded by INSOL International, on how financial pressure in local government is treated in law globally. Also in November, Professor Geo Quinot participated in a training event for senior government officials from the MENA region on public procurement and governance at the ILO's International Training Centre in Turin, Italy. 

Dekaan begin tweede termyn



Met die aanvang van haar eerste vyf-jaar termyn in 2017, het sy haar prioriteite soos volg opgesom "As far as law faculties are concerned, there is a need for us to critically reflect on the transformative nature of legal education in South Africa in order to promote social justice, the impact and effectiveness of our programmes, the imperative of renewed emphasis on ethics in our programmes and research, the considered transformation of our staff and students, the professional development of staff and finding innovative ways to increase access whilst providing sufficient support to maintain good success rates and the delivery of wellrounded, knowledgeable, skilled, and ethical graduates."

Professor Smit meen dat ten spyte van die impak van Covid-19 het die Fakulteit goed gevorder met die doelwitte wat gestel is. Met die oog op 'n tweede termyn het professor Smit in haar beskikbaarstelling vir 'n tweede termyn aangedui dat haar fokus wel in sekere opsigte sal verskuif en dat haar visie vir die volgende vyf jaar die volgende insluit: "[to] consolidate our position after COVID-19 ..., augment and maintain the wellness of staff and students, prioritise several areas identified in our Environmental Plan ..., and contribute to SU realising its Vision-2040 and Strategy."

Dit is duidelik dat daar talle planne in die pyplyn en in uitvoer is, byvoorbeeld nuwe leerstoele, die verdere uitrol van hernuwe programkurrikula, ondersteuning vir inkomende en huidige studente wie se vordering nog deur die pandemie beïnvloed word, die internalisering van die SU en grondwetlike waardes en die realisering van 'n transformatiewe studente ervaring vir elke student, uitbreiding van die ko-kurrikulêre programme, en verdere geteikende geleenthede van internasionalisering vir beide personeel en studente. In besonder is daar 'n herfokus op die Fakulteit se navorsing en nagraadse aanbiedings wat hand aan hand met internasionalisering gaan. Professor Stevens visits Germany and the Netherlands

As part of the Technische Universität München's (TUM) Global Visiting Professor Programme, Professor Richard Stevens was invited to lecture a module in the Legal Aspects of Private Equity Investment to their doctoral students between 5 June 2022 and 15 July 2022. Because Professor Stevens also lectures the Company Law module, he used his visit in München to visit colleagues in Corporate Law at the Ludwig Maximillian University in München, a university from where the Stellenbosch Faculty of Law draws a strong pool of LLM students.

During his stay in Germany, Professor Stevens spent two weeks visiting two partner faculties of the Faculty, Bucerius Law School in Hamburg and Tilburg Law School in the Netherlands. Professor Stevens was hosted by Professor Maurice Adams, vice-dean of the Law School, in Tilburg, where he met a number of colleagues in their undergraduate and postgraduate programmes, as well as colleagues in their teaching and learning division (including the blended learning team). Professor Stevens reports "the teaching and learning division of the law school is about as big as our Faculty! It was insightful to see the support that lecturers have in terms of teaching and learning strategies, assessment strategies and the creative support for blended learning where you have colleagues with legal backgrounds and professional videographers support academics with blended learning projects". A highlight of the visit to Tilburg was an invitation to be in the academic procession for the conferral of several honorary doctoral degrees.

At the Bucerius Law School in Hamburg, he was hosted by the Dean, Professor Katharina Boele-Woelki, who is also an extraordinary professor in the Department of Private Law in our Faculty. Professor Stevens spent a fruitful afternoon with the Law School's Legal Technology, Learning Innovation Lab, and student support team.

The final stop of the two-week visit was a visit to the newest partner Faculty, the Münster Law Faculty. The visit was primarily aimed to sign the exchange agreement between the two faculties and also to meet colleagues from Münster w/ho would be interested visiting Stellenbosch or this exchange programme.

He was also invited to present a guest lecture to the corporate law students on the liability within corporate groups which he presented in English and German.

Professor Stevens says: "It was wonderful to see the esteem in which our faculty is held by our partners in Europe. It was also good to see that our teaching, learning, and assessment practices are closely aligned to practices of our partners even though the support for teaching and learning is something we can only aspire to have. Being able to teach in person again was also a wonderful experience especially at the level of the doctoral students. It was also so good to see Wayne Chinembiri, former assistant in the Department of Mercantile Law and currently doctoral student, at TUM again."

A senior lecturer in the Department of Public Law, Dr Delano Cole van der Linde, provided commentary on various news events.

- In an article featured in the <u>Sunday Times</u>, Dr van der Linde calls attention to sections of the Unlawful Entry on Premises Bill.
- In a Netwerk24 article, "<u>Só kan die Guptas agter tralies</u> <u>beland</u>", Dr van der Linde discusses money laundering, flight risks, and witness immunity.
- Dr van der Linde comments on the role and responsibilities of the national commissioner as dictated by the Constitution in response to allegations on <u>SABC News</u> that Police Minister Bheki Cele is disregarding boundaries.
- Dr van der Linde was also cited in a recent judgment by the Western Cape division of the High Court. In *S v Davids and Others* ZAWCHC 216 (31 October 2022).

Henney J highlighted some of the evidentiary complexity relating to the prosecution of organised crime offences and referred to Dr van der Linde's article "Evidentiary and procedural issues relating to the prevention of Organised Crime Act" (2020) 137(3) in the *South African Law Journal*.

Several colleagues and post-doctoral fellows have published op-eds, articles etc. A couple of these include two by Dr Kavuro, who has published on the topical matter of refugees and xenophobic violence: "World Refugee Day – SA leaves the displaced in the lurch as 'global asylum fatigue' sets in" and "Refrain from name-calling - it fuels xenophobic violence". See also Professor Ruppel's article, "Fifty years after Stockholm Conference we face multiple hells, but 'only one Earth", before world environmental day, and interviews with Dr Cecile de Villiers on her doctoral research on eTV: and eNCA.

His publications have been cited with approval by top courts, including the South African Constitutional Court, and leading authorities in various countries across the continent. Over the years, he has offered advisory services to Civil Society Organisations, governments, and

UN agencies as part of a team offering consultancy services on the rule of children's rights in Africa. In his previous roles, Dr Moyo has worked with regional bodies, governments, and non-state actors in

> the field of children's rights and has supported the African Committee of Experts on the Rights and Welfare of the Child to produce high level continental study reports and normative frameworks and guidelines on various issues affecting children in Africa. He is also an external expert to the Committee's Working Group on Children with Disabilities in Africa. We trust that Dr Moyo will enjoy an enriching, collegial, and productive career at Stellenbosch University.

Farewell | Afskeidsgroet Sonia Human

On 26 October, 65 years ago, Cornelia Sophia Human was born. Her mother preferred the name Sonia, after Sonia Henny, the world-renowned ice-skating star. Sonia did not make her mark as ice skater. Instead, she made her mark where it really mattered: here in Stellenbosch, at the Law Faculty, and in our hearts.

Sonia was one of the first people I encountered when I joined the Faculty almost 29 years ago. At that stage we were both young academics, she lectured Law of Succession and Deeds and Registries, and I lectured Roman Law and Property Law. We did not know what was more dubious at that stage: her military background or my Potch background! Fortunately for me, we became fast friends and later also members of 'Die Hoek'.

Over the years we attended numerous conferences together. Two stand out: the first a Scandinavian conference that started in Denmark, then Norway and Sweden and for good measure we also added Finland, where Sonia did a marathon; and the second, Utah, where I did my first and only half marathon, with Sonia coaching me all the way. Coaching, guiding, and mentoring - these are some of Sonia's real strengths, whether in the Faculty or on the road.

Sonia is an excellent colleague and a well-loved, respected lecturer. For many years, she received the best loved lecturer award – a prize based on the final years' votes. She is also a seasoned promotor with many doctoral candidates, including some of our colleagues, under her belt.

She is also a former dean, with a stellar legacy. She was dean in a very turbulent, volatile time in tertiary education, around 2015 to 2017: in the time of 'Rhodes must fall', 'Fees must fall', and at Stellenbosch specifically, also "Open Stellenbosch" and "die taalkwessie", where she was regularly confronted by all sides – those in favour of as well as those against retaining Afrikaans as main language of tuition. Again, she remained steadfast and focused.

The Dean's Bursaries is her legacy, an initiative that enabled, and continues to enable, scores of postgraduate students to complete their studies successfully. The now well-established walk from the Coetzenburg Centre back to the Old Main Building for celebrations after graduation, is her brainchild, a wonderful tradition that has grown and is now synonymous with graduating at the Stellenbosch Faculty of Law: A festive, yet prestigious walk along Oaklined trees, with Faculty, supporters, and family members. She was a gracious leader who introduced more transparency in management structures at Faculty level. V She never shied away from duty and responsibility, including an exemplary performance as chair of the Student Disciplinary Committee, over many decades.

I always thought Sonia's surname is so very apt: she is indeed very human. She is kind, friendly and goes to great lengths to try and understand another person's point of view – to put her in that person's shoes, so to speak.

Sonia is indeed retiring at the end of the year, but we are very happy that she is staying on as emeritus professor. As Vice-Dean: Research and Internationalisation, I am very happy about the next cohort of postgraduate students that she will still deliver. As colleague and friend, I am very happy that we can all still benefit from her years of experience and wisdom. One of the many pearls of wisdom that I personally fall back on regularly is: 'Hou perspektief!'

The semester exchange programme is one of the ways the Faculty of Law pursues its strategic objective of internationalisation.



Christof Heyns African Human Rights Moot Court

From 24 to 31 July, Ms Margeaux Wassenaar and Mr Yanga Keva participated in the 31st Christof Heyns African Human Rights Moot Court Competition held in Cairo, Egypt. The competition, held annually in a different country on the continent, covers human rights issues with arguments presented to a fictitious African

Human Rights Court. This year the topics concerned human trafficking, climate justice, and social media and AI regulation.

Ms Wassenaar and Mr Keva started preparing for the competition in March with extensive for the research memorials. This was an important foundational phase to preparing for the competition as they did not have much international or regional law knowledge. However. with the expert quidance of Professor Annika Rudman



and Ms Claire Rankin (a past-participant and coach), they managed to submit excellent memorials that placed second overall in the competition.

The competition was hosted by the British University in Egypt with more than 30 teams competing in French,

Arabic, Portuguese, and English. Although, they experienced some difficulties in the dorms, they managed to put their best foot forward in the first round on Monday. Each round proved to be more challenging than the last, as the judges tried to discern who would be able to progress to the next round.

Late on the Wednesday evening, they found out that they had made it through to the finals. By way of a draw from a hat, they were paired up with the teams from Kwame Nkrumah University in Ghana; Félix Houphouët-Boigny University in Ivory Coast; and Makerere

University in Uganda to represent the respondents. As a team, it was their responsibility to work together on the Thursday to prepare combined memorials and decide on final arguments and speakers. The students reflect that "This proved to be particularly tricky as we had been paired with a French-speaking team and the translation services provided were inadequate. Nevertheless, we managed to submit the new memorials, part of which was in French, and enjoy the excursion day on the Friday - something which few finalist teams had been able to do over the years of the competition. Some of the highlights of this excursion were the pyramids, the sphinx, a papyrus museum, and a Bedouin village."

The finals, presided over by a bench consisting of five judges including the Vice-President of the African Human Rights Court and the Vice-Chairperson of the African Commission, were particularly challenging as translation services made it difficult to understand the arguments that were presented by the opposing team and the questions posed by the bench. Nevertheless, through crafty arguments presented by the combined team, with Mr Keva representing Stellenbosch University, they managed to convince the court to find in their favour.

Ms Wassenaar writes that "The months of hard work, perseverance, and juggling academic responsibilities were incredibly fruitful and we have become better mooters with a wealth of knowledge on different African and international law instruments." Ms Wassenaar expressed their gratitude to the Faculty, Professor Rudman, and Ms Rankin, without whom participating in this competition would have been impossible.



Al and the Law

The Faculty, in collaboration with Swart Law - a local firm specialising in entrepreneurial technology and intellectual property law - hosted a seminar series on "AI and the Law" in the second semester of 2022. Following discussions in 2021 initiated by Mr Derick Swart (an alumnus of the Faculty), a series of lectures involving approximately 50 undergraduate and postgraduate law students across 5 virtual seminars, commenced on 21 September. The sessions were facilitated by Dr Bradley Greenhalgh, the Faculty's Legal Education and Student Coordinator. The seminar series commenced with an opening function hosted at the Faculty, which saw presentations by Mr Swart, Professor Kanshukan Rajaratnam (Director of the School for Data Science and Computational Thinking at SU), and Dr Dirk Brand (Extraordinary Senior Lecturer at the School of Public Leadership at SU) on the intersection between Artificial Intelligence (AI), ethics, and the law. Professor Rajaratnam and Dr Brand also hosted the first of the virtual seminars. Each of these saw engagement between Mr Swart and various co-presenters, and focused on particular themes of AI and the law in the context of the South African and foreign/international legal spheres. Topics included exploring the (legal) initiatives currently in place seeking to regulate AI, consideration of the European Union's AI Act, unpacking machine learning in the financial services' industry, AI and intellectual property, as well as AI and legal technology. Guest presenters included Dr McElory Hoffman from Praelexis, Ms Ingrid Fourie, and Law Faculty alum, Ms Lara Wessels (both from Swart Law). Professor Sadulla Karjiker, the Faculty's Anton Mostert Chair in IP Law, also contributed to the discussions. Upon the completion of each seminar, the participants were tasked with completing individual online questionnaires that assessed their knowledge of the subject matter presented, and required reflection on what had been learnt and the implications thereof towards the future of Al and the law. The seminar series concluded with a final written assignment in the form of an opinion piece on the ethical need for legal practitioners to use technology in service to their clients. Participants, who successfully completed the seminar series, will receive certificates from Swart Law, with the latter providing prizes for the best opinion pieces and most active contributor. The Faculty looks forward to formalising the seminar series going forward in order to grow the co-curriculum offering available to our students, and celebrates the opportunities afforded by the interaction between local law firms and our alumni.



The **ACFE** visits the Faculty's BAccLLB Students

Members from the South African chapter of the Association of Certified Fraud Examiners (ACFE) were hosted by Silke de Lange at the Faculty on Friday, 30 September 2022, and did a presentation for our BAccLLB students. The four speakers were Helen du Toit (Head of Business Integrity at Santam), Megan Govender (head of the Forensic Services department at the Sanlam Life & Savings Cluster), Kotie Oosthuizen (Regional Head of Forensic Investigations at ABSA), and Johan van Dyk (Executive Head for Forensics at XTND, which is part of the EOH Holdings Group).

The ACFE is the world's largest anti-fraud association, which empowers anti-fraud professionals with leading-edge training, resources, and professional certification. The association facilitates individuals to become qualified as certified fraud examiners (CFEs), who are then regarded as leaders in the anti-fraud community and specialists in the prevention, detection, and deterrence of fraud. Our BAccLLB students are ideally suited for a career in this area, irrespective of whether they decide to qualify as a chartered accountant or as a lawyer upon the completion of the degree. The knowledge, skills, and dispositions acquired during the course of the degree in the fields of law, finance, and auditing are clearly extremely relevant and important in this area, where there is a clear intersection between law and accounting.

Both the speakers and the students were extremely enthusiastic and keen to cooperate further. The establishment of an ACFE student chapter at SU, the first one at a South African university, is now underway.

Children's rights reading group

Undertaking a Doctorate in Law can be daunting and, at times, may feel incredibly overwhelming. The process of researching and writing a proposal and dissertation can only be described as a roller coaster of emotions. There are high points when students are energised and excited about their research and other times when self-doubt and, occasionally, imposter syndrome creeps in.

It is during these low points, when a student is spending hours alone in the library or at their home desk, poring through case law, legislation, treaties, and textbooks, that they may realise how solitary a doctorate can truly be. It can also feel frustrating that there are not many opportunities to share and get feedback on your research outside of the formal feedback from your supervisor.

It was for this reason the Children's Rights Reading Group was created. Spearheaded by second-year LLD student, Bryony Fox, the Reading Group is made up of five LLD students who are researching in the field of international children's rights. All five are also primarily supervised by Professor Sonia Human and are grateful for her input and help in establishing the group.

The group is conducted by way of monthly meetings. The students are chosen on rotation as the session leader and may either share a particularly difficult article, case, or reading with which they are grappling and ask for the group's thoughts and opinions on the reading. Alternatively, they present an aspect of their research on which they would like feedback and opinions. This has been greatly successful in allowing not only for ideas to be discussed and shared freely, but also allowing the students to practise their presentation skills in a safe learning environment.

In addition to the students' various presentations, the group also organised information sessions on research skills and techniques. The sessions, presented by the Faculty librarian, Mr Pieter du Plessis, were informative and interesting.

The group members strongly believe the reading group not only allowed them to function as a small community that supported each other when needed, but it also strengthened their research abilities.

The group hopes to carry on its role as a feedback and support mechanism, which strengthens the research of its members, in 2023.

University. This year, we conducted five sessions through which we reached approximately 800 individuals.

Nairobi, Kenya. Our colleagues from East Africa are conducting a benchmark exercise to gather information to improve their own clinical program. In the process, they also shared their own experiences and expertise with our clinicians, staff, and students at the Clinic and Faculty of Law.

Annette King passed away peacefully at her home in Somerset West on 5 September 2022. She joined the Department of Public Law as secretary on 1 August 1986 and retired from this position at the end of 2018. She served the department for more than 30 years with distinction. Annette (or Mrs King as she was also known) is described by her colleagues as a caring person, with a warm and compassionate personality. She was regarded as a mother figure in the department (and wider faculty), to colleagues and students alike. Colleagues remember her as a person with a great sense of humour, but also someone who could call a spade a spade. Even after formal retirement, Annette could still be relied upon for support, a friendly smile, or word of encouragement. At the time of her passing, she was the part-time administrative officer of the South African Research Chair in Property Law.

She will be missed. Our thoughts and prayers go out to her family, friends, and colleagues.


"There are many who shape one's (academic) career, but in my experience, it is mostly only those with fancy titles that are called mentors and are lauded for such contributions, while, in reality, it is often those behind the scenes, outside of the limelight, that play the most significant role in steering one in the right direction.

Annette often joked that she raised me by hand, but it wasn't just a joke. She was the secretary of the Departments of Latin and later Public Law when I was an undergraduate student in those departments and became my rock when I joined Public Law as a young (and somewhat bewildered) academic. She could answer any administrative question and knew exactly who to call within the university to get things done. When I later served as HOD of the Department, I soon realized that she knew much better how to run the Department than I ever would. But, more than that, Annette was the embodiment of a caring community – she truly cared, in a deep and personal way, for every human around her, even those that caused her much anguish.

Colleagues like Annette are indispensable to success (and joy) in academia. We've missed her every day since she retired and will miss her even more acutely with her passing. I offer thanks for having known Annette King and for the tremendous role that she has played in my academic life. My life was the better because of her and I will strive to live by the same code of care that she embodied.

There was an iconic movie in the 1950s called "The Quiet Man". It was much celebrated and was nominated for several awards. It was not about George Pretorius, but it might as well have been, because its title fitted him perfectly as a description of his demeanour. George was indeed a quiet man, but when speaking his intellect and character boomed forth loud and clear, and his words carried great weight and commanded respect. He was the very antithesis of those described by the saying "empty barrels make the most noise"; he made little noise, while his barrel was full to the brim. He may have been quiet, but was not necessarily silent, particularly when the occasion arose to express his firmly held beliefs and views, which he did in a forthright manner. When he spoke, people listened!

George Archibald Clarke Pretorius was born on 19 February 1942. He grew up in Brits in the then Transvaal, where he had his schooling. He spurned his family's tradition of studying at the University of Pretoria and instead elected to become a Matie. He studied law at Stellenbosch University, attaining his LLB degree in 1966. He excelled at sport during his student days, particularly in athletics, where he was a champion hurdler, and in rugby where as a fleet footed wing three-quarter he toured with the Maties First XV. His leadership qualities came to the fore when he was appointed Primarius of Helderberg Residence.

George's decision to study at Stellenbosch proved to be a fateful one. For there, he discovered the two enduring loves of his life - the Western Cape and Brenda Joubert, whom he married in 1966, the moment the ink on his degree certificate had dried. He carried these loves through to the end of his days. They fed his soul and enriched his life.

I met George during our fourth year of legal studies. I grew to know him and respect him, and was fortunate enough to forge a firm friendship with him over the next two years leading up to our graduation. This largely came about through a practice that developed for George, Bill Daly, Pieter Le Roux and I to troop off to have coffee at the Eike Kafee or the Barracuda Restaurant after nearly every day's classes. We shared thoughts, hopes, problems, interests, as well as trials and tribulations arising from our studies and lives in general, and got to know one another pretty well. I learned that, despite the fact that George sought, and attained, complete anonymity in class (I doubt that he ever asked a question or ventured a comment throughout the two years of LLB), he had a deep and comprehensive knowledge and understanding of the law we were being taught, and had all the credentials to make an excellent lawyer, which indeed turned out to be the case. I also discovered that he had a delightful personality (despite being somewhat dogged and obstinate in his views), was intelligent, able and caring, and that he made a good and loyal friend. These perceptions were confirmed and reinforced over the next fifty-six years of our valued friendship.

When George married Brenda at the end of 1966, I acted as the best man at their wedding. It transpired that Brenda and Dana, whom I was dating at the time and whom I subsequently married, had been classmates at high school. This served to strengthen the bond between George and me, and indeed between the two couples. These bonds continue to the present day, but alas George

is no longer bound by them although this memory will forever be an integral part of them.

While LLB students, George and I had a common ambition. We both aspired to enlist in the Department of Foreign Affairs and become diplomats. Somewhere along the line before the critical day, Brenda advised him that to be a diplomat he would have to be sociable and diplomatic. Since he had neither of these character traits, the diplomatic service was not for him; he had better stay with law. Becoming an advocate required one to have public speaking skills, for which he had neither the aptitude nor the inclination, so he had better become an attorney. He heeded her advice and embarked on a career as an attorney. I followed in his footsteps after a brief interlude in the diplomatic service. I can't help feeling that he conned me into joining the diplomatic corps, only to abandon our joint endeavour at the eleventh hour and leave me out on a limb!

He served articles with Dichmont and Dichmont, a Cape Town firm, and soon after being admitted as an attorney in 1968, he and Brenda decided to seek their fortune in the City of Gold. They migrated to Johannesburg, thus reluctantly deserting the Western Cape (but vowing to return someday, as to the promised land), where George joined the substantial Johannesburg attorneys' firm, Cliffe, Dekker and Todd, initially as a professional assistant and later, in 1971, as a partner. He remained a significant and esteemed partner of the firm until 1999 when, as the firm engaged in mergers with foreign and local firms to become a mega firm (which did not find favour with him), he relinquished his partnership and elected rather to become a consultant to the firm. A year later the call of the Western Cape became irresistible, and he relocated to Erinvale Estate in Somerset West to set up his own individual practice dealing with litigation and, in particular, arbitrations. He continued to practise successfully in this field until his untimely death in July 2022.

When I left the Department of Foreign Affairs and sought employment as an articled clerk in a firm of attorneys, George did his level best to have Cliffe Dekker and Todd hire me. However, as a married man supporting a wife and two children, my financial requirements were too rich for the firm's diet and his efforts came to naught. I appreciated his willingness as a true friend to help me. I subsequently found my niche with a firm of specialist intellectual property attorneys in Pretoria. While we lived in Pretoria, we retained contact with Brenda and George and saw them intermittently. Our friendship remained strong.

In 2007, with retirement looming, my wife and I, being natives of Cape Town, decided that our 40-year period of exile in Pretoria should end and we followed George and Brenda's lead and returned to the promised land. We settled in Stellenbosch, a stone's throw away from Somerset West and the Pretorius household. Being new to the area after our long sojourn in Pretoria, we knew few people. George took me under his wing and for the best part of the next five years, we met weekly for lunch. Thereafter our lunches became less frequent due to other demands on our time, but we continued to break bread together from time to time, often accompanied by Poen Hoffman, a classmate from LLB days, who had hailed from Malmesbury and had also done time in Pretoria for several years before heeding the call of the Cape and returning home. It was like old times at the Eike Kafee.

In the meantime, the quiet man had also become a solitary man. That is not to be confused with a lonely or reclusive man, which he was not. Operating alone as a sole practitioner from his home, George increasingly kept his own company, which he enjoyed. He liked the company of others (and they enjoyed his), but on his own terms, and when he felt the need for it. He was, and always had been, essentially a loner.

His one-man band comprised Brenda, a Latin teacher, as his secretary-cum-PA and girl Friday. It was perfectly in order for George, who was steeped in propriety, to have a love affair with his secretary and to shack up with her. Moreover, as we were taught by our professors, and as was necessary for all good lawyers, he now had a proper grounding in Latin. A *vincula matrimonii* – From the bond of matrimony!

He was an ardent golfer and an active participant in the Erinvale Golf Club, where he soon became the in-house legal adviser. This gave him ample social interaction for his liking. He became an institution in the golf club. Committees (which were not for him) and Chairmen came and went but George was a constant presence. He became the power behind the throne. It reached the point where successive Chairmen would not move without first consulting George on legal and other issues. The esteem and affection in which he was held by the members of the golf club was evidenced when, upon his passing, the Golf Club spontaneously held a function to commemorate his life.

One of the sociable highlights of George's life, where he could indulge himself by enjoying ample company, was to participate in the annual 'Mannetoer'. This was a gathering, usually lasting three days, of a bunch of twenty or so ex-Maties of the 1960s vintage, at a lodge or guest accommodation venue in some out of the way place; it involved telling stories over a braai and a few beers or glasses of wine and reliving the days of yore at Matieland. Poen Hoffman, Bill Daly, and I were also part of the team. With Poen replacing Pieter Le Roux, this was also a reunion of the Eike Kafee crew. Poen was wont to refer to us as the 'Fab Four'. At least in our own estimation, we were indeed. Such is the nature of long-lasting and true friendship.

As part of his penchant for solitude, George and Brenda acquired a holiday get-away at Nature's Valley where

he could go native to his heart's content. He loved the remoteness and peaceful atmosphere of Nature's Valley. They spent several weeks, if not months, each year at this favourite spot. Indeed, George seriously considered going to live there permanently. However, Brenda, who was generally prepared to let George have his own way, balked at this notion and his plans were put on hold, never to be fulfilled.

George enjoyed an enviable, well-earned, reputation as an attorney. His incisive mind, determination to do the best for his clients, knowledge of the law, and discernment characterised his success. The top lawyers in the country rightly considered him as their peer. Above all, he was ethical and honourable to a fault. His clients could always be assured that they were in good hands and that he would pursue their interests to the utmost degree and to the best of his considerable ability.

He was a good husband to Brenda (a guality that she reciprocated wholeheartedly) and an admirable father to his children Jan, Carolyn, and Louise, as well as a much loved and doting grandfather. A measure of the affection and loyalty that he engendered with his children was demonstrated when, upon hearing of his failing health, they all immediately dropped whatever they were doing in far flung parts of the world and rushed to gather at his bedside to be with him and their mother, and to pay their last respects to him.

George Pretorius, the quiet man, may have been somewhat unobtrusive by nature, but his firm voice will remain and resonate indefinitely in the minds and memories of those who had the privilege of knowing him.

Owen Dean (the first incumbent of the Anton Mostert Chair of Intellectual Property Law until 2015), 16 September 2022

Albert van Niekerk: 'n Man van durf en daad wat 'n verskil hier gemaak het

en van die land se voorste gewese diplomate en ambassadeurs, Albert van Niekerk, is in die Mediclinic Vergelegen-hospitaal in Somerset-Wes aan limfoom en longontsteking oorlede. Hy was 82.

In die aanbeveling vir 'n erepenning wat hy van sy alma mater die Hoerskool Jan van Riebeeck in 2005 ontvang het, skryf hulle dat Van Niekerk 31 jaar lank in Suid-Afrika se diplomatieke diens was en dat hy 18 jaar lank in oorsese poste in New York, Washington (DC), Tel Aviv, Bonn (twee maal, die tweede keer as ambassadeur) en Londen gedien het.

Hy het vyf afdelings in die departement van buitelandse sake gestig, asook 'n nuwe konsulaat-generaal in Israel in 1972, wat later 'n ambassade geword het. Van Niekerk was ook deel van die diplomatieke span wat voor die 1994-verkiesing top-ANC-politici en ander leiers met uitgebreide oorsese reise tot die werkveld van die diplomatieke diens georiënteer het.

Die afgelope jare het hy en sy gade in Somerset-Wes gewoon. Sy vrou, Katinka, sê: "Hy was die gelukkigste in twee stede: Tel Aviv en Bonn. Sy geluk daar was direk verbind aan die genot en vervulling wat hy uit sy werk geput het."

Hulle het in hul eerste jaar op Stellenbosch ontmoet: "Dit was tydens die jooloptogte waar ons geld moes insamel om die Neelsie te bou wat nou jare later stewig op die Stellenbosse kampus staan. 'n Foto is geneem van hom en sy boesemvriend André Walters met my en my

vriendin op jooldag. Ek en Albert het dus 64 jaar lank saam (sy aan sy) deurgebring, waarvan ons 58 jaar getroud was."

Sy dogter, 'n sielkundige en voormalige aktrise, Jana van Niekerk, onthou: "Hy was by my toe ek my eerste asemteug

ingehaal het. My pa het op my gewag sodat ek by hom kon wees voordat hy sy laaste een kon uitblaas. Hy is so grasieus weg.

"Om die digter Mary Oliver te parafraseer: 'Hy het vir my 'n boks met lig gegee, een waarvan ek die geskenke steeds uitpak.' Dankie dat jy my pa was."

Sy ander dogter, die romansier Elizabeth Lowry wat in Oxford woon, sê: "My ambisies het altyd vir hom saak gemaak, al was dit lees, skilder of skryf. Hy het vir my elke boek denkbaar gegee.

"Toe ek grootword, het hy my laat voel soos 'n mens in my volle reg. Van my vroegste herinnering aan hom is waar hy by sy lessenaar sit, omring met lêers, memorandums, toesprake, boeke en koerante. Hy het wyd gelees, was konsensieus

met sy werk, maar het ook vlieërs op die strand gevlieg, was lief vir rolprente en het selfs gerolskaats."

Albert Erich van Niekerk is in Windhoek gebore en het aan die Hoërskool Jan van Riebeeck in Kaapstad gematrikuleer. Daarna het hy regte aan die Universiteit Stellenbosch studeer. Sy pa, Albert, en ma, Erna, het in 'n stadium in die Grootfontein-distrik geboer. Hy was ook lid van die Diamantraad en parlementslid vir Etosha. Sy ouers het dus ses maande van die jaar gedurende die parlementsitting in die Kaap deurgebring.

'n Vriendin, die joernalis Amanda Botha, sê: "So 'n besondere man! Hy het 'n verskil gemaak in die makro- en mikrobestaan van ons land, sy mense en in individuele lewens, waarvan ek ook 'n ontvanger was. Albert was 'n man van durf en daad. Ek eer sy nagedagtenis."
