# Boodskap van die **Dekaan**

#### Beste kollegas, studente, alumni en vriende

Dit is met groot plesier dat ons hierdie nuusbrief met julle deel. Die Fakulteit Regsgeleerdheid het die 2025 akademiese jaar met hernieude entoesiasme begin.

Hierdie jaar het ons 'n diverse groep eerstejaarstudente verwelkom, insluitend LLB (vierjaar) studente, BA (Regte) studente, BCom (Regte) studente en BRek LLB studente. Daarbenewens het ons die eerste finalejaargroep van ons hernieude LLB-program verwelkom.

Behalwe vir 'n nuwe verpligte module in ons finale jaar (Reg en Tegnologie), het ons nuwe modules in ons kursuswerk LLM-programme ingesluit, spesifiek in Stedelike Reg en Klimaatreg en Volhoubaarheidsregeerkunde. Ons het ook 'n nuwe kortkursus bekendgestel, getiteld Klimaatsveranderingsreg vir Plaaslike Regeringsaksie.

'n Noemenswaardige prestasie is die stigting van die Prestige Beurse vir Regte, geborg deur die Regsfakulteit Trust. Hierdie omvattende beurse is toegeken aan twee uitsonderlike studente, wat gekies is op grond van akademiese meriete, 'n kort opstel en 'n onderhoud met lede van die Fakulteit en die Regsfakulteit Trust.

Dit is noodsaaklik om te erken dat studentesukses beduidend beïnvloed word deur holistiese ondersteuning, insluitend toegang tot voldoende finansiële hulpbronne wat bydra tot voldoende studiegelde, verblyf, voedselsekerheid, reiskoste en studiemateriaal. Met die ruim ondersteuning van die Regsfakulteit Trust en ander alumni en skenkers, benewens die voorsiening van pryse, kon ons vanjaar ongeveer R5,5 miljoen in beurse aan regstudente versprei. Ons betuig ons opregte dank aan elke skenker en ondersteuner van ons studente, aangesien u bydraes 'n diepgaande impak op die sukses van hierdie studente maak en terselfdertyd langtermynbelegging 'n in ons samelewing verteenwoordig.

Die Fakulteit het sy onderneming om navorsingsgebaseerde kollokwiums op sleutelgebiede te organiseer (soos internasionale privaatreg, demokrasie en die sosiale staat, groepsgedinge en straf(proses)reg), gehandhaaf. Hierdie semester het ons drie openbare lesings suksesvol aangebied. Die lesings is met 'n hoë vlak van bywoning begroet en het besprekings oor kontemporêre kwessies aangemoedig. Die komende tweede semester sal 'n uitbreiding van sulke navorsingsintensiewe byeenkomste sien en verdere geleenthede vir betrokkenheid bied.

In antwoord op institusionele verwikkelinge is sekere aanpassings aan die leierskap van die Fakulteit aangebring. Met ingang van 1 April het professor Richard Stevens die rol van Waarnemende Viserektor: Leer en Onderrig aanvaar. Terselfdertyd het die vertrekkende Bedryfshoof (professor Stan du Plessis) my formeel opgelei voordat ek die posisie as Waarnemende Bedryfshoof vanaf 1 Junie 2025 aanvaar het. Professor Juanita Pienaar het die rol van Waarnemende Dekaan aanvaar, professor Bradley Slade het as Waarnemende Visedekaan Leer en Onderrig ingetree, en professor Theo Broodryk het vanaf 1 Julie die rol van Waarnemende Visedekaan Navorsing en Internasionalisering aanvaar. Saam met professore Sadulla Karjiker, Anél du Plessis, Geo Quinot, mev. Karin Wiss en dr. Franziska Myburgh, gaan die Fakulteit voort onder leiding van die hersiene Fakulteitsbestuurskomitee.

Die huidige tydperk is 'n noemenswaardige tyd vir die onderrig en studie van regte. Die verreikende wêreldwye ontwikkelings wat in onlangse maande waargeneem is, die onlangs vrygestelde kwartaallikse arbeidsopnamestatistieke en die bekendstelling van belangrike nuwe (en voorgestelde) wetgewing bied ruim gevallestudies vir klasbesprekings en interessante navorsingsnavrae. Dit beklemtoon die beduidende verantwoordelikheid wat verband hou met die titels van 'regspraktisyn', 'akademikus' of 'leier' in ons veld, wat die handhawing van geregtigheid, die dien van die openbare belang en die bydrae tot 'n meer billike samelewing behels.

Soos die semester tot 'n einde kom, wil ek ons personeel en studente bedank vir al hul harde werk en toewyding. Ek hoop julle almal geniet 'n ontspannende en welverdiende ruskans!

# Message from the Dean

#### Dear colleagues, students, alumni, and friends

It is with great pleasure that we share this newsletter with you. The Faculty of Law commenced the 2025 academic year with renewed enthusiasm.

This year, we welcomed a diverse cohort of first-year students, including LLB (four-year) students, BA (Law) students, BCom (Law) students, and BAccLLB students. Additionally, we welcomed the inaugural final-year group of our renewed LLB programme.

Other than a new compulsory module in our final year (Law and Technology), we have introduced new modules into our coursework LLM programmes, specifically in Urban Law and Climate Change and Sustainability Governance. We have also launched a new short course, titled Climate Change Law for Local Government Action.

A notable achievement is the establishment of the Prestige Bursaries for Law, sponsored by the SU Law Trust. These comprehensive bursaries have been awarded to two exceptional students, who were selected based on academic merit, a short essay, and an interview with members of the Faculty and the Law Trust.

It is imperative to acknowledge that student success is significantly influenced by holistic support, including access to adequate financial resources that contribute to adequate tuition, accommodation, food security, travel costs, and study materials. With the generous support of the SU Law Trust and other alumni and donors, beyond the provision of prizes, we were able to distribute approximately R5,5 million in bursaries to law students this year. We extend our sincere gratitude to every donor and supporter of our students, as your contributions make a profound impact on the success of these students and, simultaneously, represent a long-term investment in our society.

The Faculty has maintained its commitment to organising research-based colloquiums in key areas, such as private international law, democracy and the social state, aggregate litigation, and criminal (procedural) law. This semester, we successfully hosted three public lectures, which were met with a high level of attendance and facilitated engaging discussions on contemporary issues. The upcoming second semester will witness an expansion of such research-intensive gatherings and provide further opportunities for engagement.

In response to institutional developments, certain adjustments were made to our Faculty leadership. Effective 1 April. Professor Richard Stevens assumed the role of Acting Deputy Vice Chancellor Teaching and Learning. Simultaneously, I formally shadowed the departing Chief Operating Officer (Professor Stan du Plessis) prior to assuming the acting COO position from 1 June, 2025. Professor Juanita Pienaar assumed the role of Acting Dean, Professor Bradley Slade served as Acting Vice Dean Teaching and Learning, and Professor Theo Broodryk took on the Acting Vice Dean Research and Internationalisation role from 1 July Alongside Professors Sadulla Karjiker, Anél du Plessis, Geo Quinot, Mrs Karin Wiss, and Dr Franziska Myburgh, the Faculty continues under the guidance of the revised Faculty Management Committee.

The current period presents a notable time for teaching and studying law. The far-reaching global developments observed in recent months, the recently released Quarterly Labour Survey statistics, and the introduction of key new (and proposed) legislation provide ample case studies for class discussions and intriguing research inquiries. This underscores the significant responsibility associated with the titles of 'lawyer,' 'scholar,' or 'leader' in our field, which entails upholding justice, serving the public good, and contributing to a more equitable society.

As the semester comes to an end, I want to thank our staff and students for all their hard work and dedication. I hope you all have a relaxing and well-deserved break!

Boogxa, bafundi, zithwalandwe, nabahlobo ababekekileyo

Kuluvuyo olukhulu ukwabelana nani ngale ncwadana yeendaba. IFakhalthi yezoMthetho iye yaqalisa unyaka wezifundo ka2025 ngovuyo oluhlaziyekileyo.

Kulo nyaka, siye samkela iqela elizintlobontlobo labafundi abenza unyaka wokuqala, kuquka abafundi beLLB (yeminyaka emine), abafundi beBA (ezoMthetho), abafundi beBCom (ezoMthetho), nabafundi beBAccLLB. Ukongeza, siye samkela iqela lokuqala elenza unyaka wokugqibela kwinkqubo yethu yeLLB ehlaziyiweyo.

Ngaphandle kwemodyuli entsha enyanzelekileyo kunyaka wethu wokugqibela (ezoMthetho neTekhnoloji), siye sazisa iimodyuli ezintsha kwiinkqubo zethu zomsebenzi wezifundo zeLLM, ngokungqalileyo kwezomthetho wasezidolophini noGuquguquko lweMozulu noLawulo obuluQilima. Siye kananjalo saphehlelela isifundo sexesha elifutshane esitsha, esihloko saso sithi uMthetho woGuquguquko lweMozulu ukulungiselela amaNyathelo ooRhulumente beeNgingqi (Climate Change Law for Local Government Action).

Impumelelo eqaphelekayo kukumiselwa kweeBhasari zo-Dumo kwezoMthetho, ezixhaswa ngezimali yiThrasti yezoMthetho yaseSU. Ezi bhasari zibanzi ziye zanikwa abafundi ababini ababalaseleyo, nabaye bakhethwa ngokusekelwe ekusebenzeni kwabo kwizifundo zabo, kwisincoko esifutshane, nakudliwanondlebe kunye namalungu eFakhalthi neThrasti yezoMthetho.

Kubalulekile ukuqaphela ukuba impumelelo yabafundi ifumana ifuthe elibonakalayo kwinkxaso epheleleyo, kuquka ufikelelo kwimithombo yezezimali eyaneleyo nenegalelo ekuqinisekiseni imfundo, iindawo zokuhlala, ukhuseleko lokutya, iindleko zokuhamba, neemathiriyeli zokufunda. Ngenkxaso enesisa yeThrasti yezoMthetho yaseSU nezinye izithwalandwe nabanikeli, ngaphezu kobonelelo ngamabhaso, siye sakwazi ukuhambisa iibhasari ezimalunga neR5,5 yezigidi kubafundi bezomthetho kulo nyaka. Sidlulisa umbulelo wethu ongazenzisiyo kuye wonke umnikeli nomxhasi wabafundi bethu, najengoko igalelo lenu lisizisa iziphumo ezibalulekileyo kwimpumelelo yaba bafundi kwaye, ngaxesha linye, lisiza notyalomali lwexesha elide kuluntu lwethu.

Le Fakhalthi iye yakugcina ukuzinikela kwayo ekuququzeeleni iingqungquthela zezemfundo ezisekelwe kuphando kwimimandla ephambili, njengomthetho wabucala wakumazwe ngamazwe, inkqubo yentando yesininzi nobume bezentlalo, ukuthathwa kwamanyathelo ezomthetho ngokupheleleyo nomthetho wezolwaphulomthetho (wezemigaqo yomthetho). Kule simesta, siye sasingatha ngempumelelo izifundo zikawonkewonke ezithathu, neziye zazinyaswa ngobuninzi kwaye zaba neengxoxo ezingokuzibandakanya ngemiba yexesha langoku. Le simesta yesibini izayo iza kuba nokwandiswa kwezi ndibano zinje zigxile kuphando kwaye ibonelele ngamathuba angamanye okuzibandakanya.

Ukuphendula kuphuhliso lweziko, kuye kwenziwa ulungelelwaniso oluthile kubunkokheli beFakhalthi yethu. Ukuqala ngomhla woku1 kwekaTshazimpuzi, uNjingalwazi uRichard Stevens waye wangena kwisikhundla sokuba nguSekela weSekela Ngqonyela oBambeleyo kwezokuFundisa noku-Funda. Ngaxesha linye, ndiye ndalandela ngokusesikweni iGosa eliyiNtloko kwezeMisebenzi eliphumayo esikhundleni (uNjingalwazi Stan du Plessis) ngaphambi kokungena ngokusesikweni kwisikhundla sokuba nguCOO obambeleyo ukususela ngomhla woku1 kweyeSilimela, ku2025. UNjingalwazi Juanita Pienaar uye wangena esikhundleni sokuba yiNtloko yeFakhalthi eBambeleyo, uNjingalwazi Bradley Slade uye wasebenza njengoSekela Ntloko we-Fakhalthi oBambeleyo kwezokuFundisa nokuFunda, waza uNjingalwazi Theo Broodryk wathatha isikhundla sokuba nguSekela Ntloko weFakhalthi oBambeleyo kwezoPhando nezaMazwe ngaMazwe ukususela ngomhla woku1 kweyeKhala. Ngokusebenzisana nooNjingalwazi uSadulla Karjiker, uAnél du Plessis, uGeo Quinot, uNkskz Karin Wiss, noGqr. Franziska Myburgh, le Fakhalthi iqhubeleka phantsi kwesikhokelo seKomiti yoLawulo lwale Fakhalthi ehlaziyiweyo.

Esi sithuba sexesha sikuso silixesha eliqaphelekayo sokufundisa nokufunda ezomthetho. Uphuhliso lwakwihlabathi jikelele olufikelela kwiindawo ezikude oluye lwabonakala kwezi nyanga zakutshanje, iinkcukachamanani zoVavanyozimvo lwaBasebenzi lwaRhoqo ngeKota ezisandula ukukhutshwa mvanje, nokwaziswa kowisomthetho olutsha oluphambili (noluphakanyisiweyo) kubonelelwa ngemizekelo emininzi yeengxoxo zaseklasini nemibuzo yophando enika umdla. Oku kusisiseko soxanduva olubonakalayo olwayanyaniswa nezihloko ezithi 'igqwetha,' 'isifundiswa,' okanye 'inkokheli' kwikhondo lomsebenzi wethu, neliquka ukuphakamisa ubulungiswa, ukusebenzela okulungele uwonkewonke, nokuba negalelo kuluntu olulinganayo nangakumbi.

Nanjengoko le simesta ifikelela esiphelweni, ndifuna ukubulela abasebenzi nabafundi bethu ngako konke ukusebenza nzima nokuzinikela kwabo. Ndiyathemba ukuba nonke niza kuba nekhefu elipholileyo nelinifaneleyo!

## Conferences, seminars, and colloquia

The year had an early start with a Private International Law colloquium on 17 January 2025, organised by Ms Ray de Villiers, in collaboration with Professor Thalia Kruger of Antwerp University, an alumna of the Faculty of Law, and Professor Jan Neels, Director: Research Centre for Private International Law in Emerging Countries, University of Johannesburg, The

Law in Emerging Countries, University of Johannesburg. The colloquium showcased new research in the field of Private International Law, including doctoral research.



A variety of other seminars, research discussions and lectures took place, including departmental research days. The Department of Private Law **held** a research day on 19 May 2025.



#### Mercantile Law Departmental Research Seminars

The Department of Mercantile Law hosted its first research seminar for the year on 4 February 2025, at Alluvia Boutique Winery. The seminar also welcomed Professor Christoph Ann, a regular visiting academic, along with the department's new research assistants and the new postdoctoral fellow in the Chair in Urban Law and Sustainability Governance.

Dr Enelia Jansen van Rensburg, recently returned from sabbatical, delivered a paper titled, "The role of the purpose element in the South African and Belgian General Anti-Avoidance (GAARs)". Professor Phillip Sutherland, also recently returned, presented a paper titled "Delictual liability of directors to third parties". Professor Anél Du Plessis presented her paper titled, "Trade, tradeoffs, and the quest to regulate the unruly city". Professor Sope Williams concluded the seminar with a presentation titled, "Gendered corruption barriers in public procurement systems".

#### Department of Mercantile Law's first research seminar.



The Department of Mercantile Law's second research seminar was held on 20 May 2025 at ASARA Wine Estate. From Mediation to Artificial Intelligence, Deep Fakes to Workplace Law, the day was set for engagements in connection with the research being undertaken by colleagues.

The first presenter of the day (and recent LLD graduate) was Dr Gretchen Jansen. Dr Jansen presented a paper titled, "From fixation to fabrication: Performers' rights in the age of artificial intelligence". The next presenter was Dr Aisha Adam (postdoctoral fellow in the Department) with a presentation titled, "Dignity as a transformative tool in the workplace". After the tea break, Dr Victoria Banke Olagbegi-Oloba (Consolidoc in the Department of Private Law being hosted by Professor Theo Broodryk) presented a paper titled, "The Impact of court-connected alternative dispute resolution (CCADR) on the dispensation of civil justice in Nigeria: A comparison with South Africa and the USA". The seminar was closed off by Mr James Haw (LLM by research student under the supervision of Professor Christoph Garbers) with a presentation titled, "ChatGPT turns three and earns an LLB?" Legal education in the age of large language models - A student's perspective".

## The Faculty of Law Research Community: Cultivating Scholarship and Community

The Faculty of Law Research Community returned in 2025 with many fresh faces and renewed energy, committed to creating an open and collaborative space for the Faculty post-graduate students and early-career academics. Meeting monthly on Friday afternoons, this initiative, spearheaded and

facilitated by Dr Bryony Fox and Dr Tanveer Jeewa, with the support of Professor Juanita Pienaar, brings together master's students, doctoral candidates, postdoctoral researchers, and early-career faculty members in an inclusive and intellectually generous environment.

Pienaar led a foundational session on crafting an effective LLM and LLD research proposal, followed by practical insights from community members on preparing for the road ahead. Building on this strong foundation, Professor Sandra Liebenberg shared strategies for developing a focused publishing

> trajectory while managing the time pressures young academics often face. To conclude the semester, Professor Quinot delivered a seminar on enhancing research presentation skills - equipping community members with tools to disseminate their work confidently and clearly.

Beyond skill building, these gatherings have nurtured a genuine sense of

belonging and mutual support, strengthening not only the research community's academic capabilities but also the personal connections that sustain them.

This initiative would not be possible without the generosity of the Faculty's senior colleagues who so willingly share their time and expertise. The research community also extends their gratitude to Ms Shazneen Arnolds, whose administrative support ensures that the sessions run smoothly.

The Research Community offers an invaluable platform for early-career

scholars to share the daily challenges they encounter and find ways to overcome them through shared knowledge, peer support, and professional guidance. Each monthly session typically comprises two parts: a workshop led by a senior academic or practitioner, followed by a reading group where a member presents their work for discussion and constructive feedback.

This year began with a focus on supporting scholars at various stages of their academic journey. Professor

The Faculty welcomed various international scholars and visitors during the first few months of 2025. Gordon Silverstein (Assistant Dean for Graduate Programs) and Carrie Field (Director of Graduate Programs), from Yale Law School, visited the Faculty of Law on 16 and 17 March 2025. Discussions are underway to explore potential collaborations across various areas, including clinical training.

From 17 to 21 March, Professor Irene-Marie Esser, a professor at the School of Law, Glasgow University, and Dean of the Graduate School, College of Social Science, visited the Faculty. Beyond exploring future undergraduate and postgraduate collaborations, Professor Esser led a buzz group in the Department of Mercantile Law on 17 March. Her presentation was titled, "The legal dimension

of 'corporate purpose': A study of companies with a religious influence". She also delivered a guest lecture for the LLM programme, focusing on the position of stakeholders in UK company management. During this lecture, she discussed various mechanisms that support stakeholders, such as non-financial reporting, due diligence, and the role of board committees.

From 26 May to 1 June, Professor Juanita Pienaar served as a visiting professor at the Université Paris Cité, contributing to their international LLM programme in Common Law and Comparative Law.

#### **Social Justice Lecture**

The Social Justice Lecture is an annual commemoration of the United Nation's World Day of Social Justice. At the 6<sup>th</sup> Annual Social Justice Lecture, held on 20 February 2025, Lord Michael Hastings urged the audience to embrace sacrifice and solidarity in the quest for a more just and equitable society.

#### Think Tank Roundtable on Social Justice, Fiscal Policy and VAT

On 6 March 2025, the Centre for Social Justice (CSJ) and Institute for Economic Justice (IEJ) held a roundtable to evaluate revenue policies and to assess the social and economic justice implications thereof. The roundtable emphasised the need for courageous decisions that avoid placing disproportionate burdens on disadvantaged communities.

#### Social Justice Café on "South Africa's Rape Epidemic: Can mainstreaming social justice foster justice?"

The Social Justice Café, which took place on 7 May 2025, highlighted how South Africa's rape epidemic - driven by patriarchy, poverty, and a weak institutional response - persists in places like schools and workplaces where survivors are often overlooked, undermining the country's constitutional commitment to dignity, equality, and justice.

#### 2<sup>nd</sup> Annual Urban Law & Sustainability Governance Public Lecture

The ULSG Chair hosted its 2<sup>nd</sup> Annual Public Lecture on the 15<sup>th</sup> of May. This year's invited presenter was Professor Edgar Pieterse, Founding Director of the African Centre for Cities (ACC) at the University of Cape Town. The Public Lecture was titled "Truncated futures for African Cities". It served to highlight legally relevant megatrends in the urban development context with a particular focus on governance challenges facing African urbanisation, including path dependency, institutional inertia, and limited resources. This stimulating presentation also invited the audience to reimagine constructive and sustainable responses to the unique poli-crisis confronting African cities, with an emphasis on the coalescence of different fields, including law, human rights, and spatial justice.

The lecture was well-attended by SU students, staff, scholars representing other Faculties as well as members of the public.

#### Ongoing collaborative research with SALGA and KAS

This year, the Chair is partnering with the South African Local Government Association (SALGA) and the Konrad Adenauer Foundation (KAS) to develop a Working Paper titled "Urban\_Law@work for developmental local government in South Africa". The objective of the project is to identify how national and local government legislation, as well as local legislative authority, empowers or impedes municipalities in the pursuit of a 'lived' developmental local government, as originally envisioned in the White Paper on Local Government of 1998.

The project is implemented around two parts. The first is desktop research on the existing national law and policy framework directing local government affairs in the country and documented commentary on its ability to deliver; and the second is interactive discussions with organised local government and municipalities to inform understanding of the strengths and weaknesses of the said law and policy framework as experienced by local government role-players. A subsidiary objective of the project is to assess the research needs surrounding the design and implementation of local government law in 2025, thereby helping to set the future research agenda of the ULSG Chair.

As part of this ongoing project, SALGA, KAS, and the ULSG Chair co-hosted a successful, interactive workshop on 2 and 3 June 2025 at the Lagoon Bay Hotel in Cape Town. A large group of local government role-players attended the event.

# Dr Bryony Fox presents at the *"Alchemical Tales"* Conference in Cape Town

Advancing children's flourishing: Realising the child's \* right to evolving capacities in South Africa through the lens of human dignity

From 12 to 14 February, Dr Bryony Fox attended and presented a paper at the conference: "Alchemical Tales: A Conference Curated in Honour of Albie Sachs", co-hosted by the Faculties of Law of UCT, UWC and Stellenbosch University.

Joined by Caitlyn Lattimer, Dr Fox presented a Paper, titled "Advancing children's flourishina: Realising the child's right evolving to capacities in South Africa through the lens of human dignity". This paper builds on Justice Sachs' warning in the seminal children's rights case of S v M, cautioning that the overuse of the best interests principle by South African courts risks reducing it to a mere rhetorical device, no longer effectively safeguarding children's rights. The paper explores how the principle of evolving capacities, as envisioned in the UN Convention on the Rights of the Child (CRC), can serve as a meaningful judicial tool. They argue that grounding this principle the constitutional in values dignity of and human flourishina offers a framework that allows courts to both protect children from harm and respect their growing autonomy - ensuring decisions reflect each child's unique context. A fascinating discussion at the intersection of law, dignity, and child development.

Drawing on her experience from entry-level roles to executive leadership in the public sector, she unpacked some of the public sector pressures, politics, and pitfalls. She encouraged young public servants to view internships as transformational journeys with opportunities to rebuild ethical, resilient, and impactful leadership in government from day one.

## *Father-daughter* duo joins Stellenbosch University

Dr Luzuko Mdunyelwa joined the Chair in January 2025 to conduct a second doctoral degree. What makes this even more extraordinary is that Luzuko's daughter, Lindokuhle, also joined Stellenbosch University this year as a first-year student in economic management sciences and accounting.

In a brief interview with the father-daughter duo, it transpired that they both take keen interest in the law, politics and news of the day. Lindokuhle mentioned that she is "really interested in forensic accounting. I think that's a part of why the law interests me, because just the thought of being able to testify in court mixed with accounting makes me very excited." Turning to the fact that she's joined at university by her father as a fellow 'student', she mentioned that she finds it inspiring how hard her father works for what he wants - "he has remarkable determination".

Luzuko has a background in public administration and has served many years in local government. His doctoral thesis, supervised by Professor Anél du Plessis, explores aspects of urban informality through the lens of the Constitution of the Republic of South Africa of 1996.

#### Postgraduate Seminar on "The Cultivation of Your Legal Craft: Your Postgraduate Research Journey"

On 12 March 2025, the HF Oppenheimer Chair in Human Rights Law, Professor Sandra Liebenberg, hosted a lunchtime seminar in the CL Marais Building, which focused on the important topic of the journey and process of research. The seminar was well attended by SU postgraduate students.

The guest speaker for this seminar was one of the Chair's special alumnus members and current extraordinary research fellow at the Department of Public Law, Gideon Basson. Gideon is currently pursuing his DPhil in law studies at the University of Oxford, where he is also the convener of the Bonavero Graduate Research Forum. He offers research training in this convening role.

In an interactive online presentation format, Gideon presented his thoughts on what is important in the process of research and writing. From discussing broader principles such as situating one's research as part of a knowledge conversation, to drilling into finer details such as having a good filing system for one's research and being meticulous when it comes to referencing - the postgraduate students learnt some invaluable lessons from Gideon during this seminar. The Chair is extremely grateful to Gideon for his time and passion for sharing his immense research expertise.

#### HF Oppenheimer Chair Hosts Prof Fowkes on Constitutional Power



On 26 March 2025, the HF Oppenheimer Chair in Human Rights hosted Prof James Fowkes for his seminar "On constitutional power in South Africa: beyond the story of negotiation".

Professor Fowkes, Professor of Foreign and International Law at the University of Münster (Germany), who studied at Wits University and Yale Law School, challenged the widely accepted narratives about South Africa's Constitution. He disputed the conventional wisdom that portrays South Africa as having a negotiated and fundamentally value-based constitution, arguing instead that both perspectives misunderstand our constitutional foundations.

In his presentation, Professor Fowkes proposed that the South African constitutional order is fundamentally grounded in power rather than values or negotiated compromise. He characterised South Africa's constitutional development as a constructive revolution led by the ANC, comparing it to India's post-1949 constitutional order under the Congress Party as the closest historical parallel. Central to his argument was an analysis of Section 74(1) of the Constitution, which he described as revealing the true nature of our constitutional foundations. This section, requiring a 75% threshold for amending the Constitution's founding provisions, represents, in his view, not a limitation imposed on Black majority power, but rather an acknowledgement and expression of that power.

Professor Fowkes concluded by arguing that South African constitutional defenders have historically distanced the Constitution from Black democratic authority - the very force that gives it legitimacy. He called for a reframing of the constitutional narrative that acknowledges the revolutionary nature of South Africa's constitutional transformation. This perspective, he suggested, offers an understanding of the Constitution that is more faithful to South Africa's history and provides a stronger foundation for its defence in contemporary debates.

## Dr Christiaan van Schalkwyk

The HF Oppenheimer Chair in Human Rights was delighted to celebrate the LLD Graduation of Dr Christiaan van Schalkwyk in the March 2025 University Graduation ceremonies. Dr Van Schalkwyk completed his LLD under the supervision of Professor Liebenberg with a study entitled, "Integrating environmental considerations in socio-economic rights adjudication: The role of ecologically sustainable development." This study explores how the judicial enforcement of socioeconomic rights can be made more responsive to the impacts of the ecological crisis. It demonstrates how the concept of sustainable development could serve as a bridge between environmental and socioeconomic rights. It also recommends a novel approach to integrating environmental considerations in socioeconomic rights adjudication. Dr Van Schalkwyk was holder of the prestigious EP Bradlow Human Rights Postgraduate Bursary awarded to a student doing their doctoral dissertation under the auspices of the Chair.

Paying tribute to Dr Van Schalkwyk, Professor Liebenberg said:

"Christiaan made a tremendous contribution to the Oppenheimer Chair in Human Rights Law over the past 4 to 5 years. He was a brilliant research assistant when I served on the UN Committee on Economic, Social and Cultural Rights; took responsibility for organising the inaugural Chair's Postgraduate Human Rights Seminar; assisted myself and Ms Margot Strauss to transition to online teaching of Constitutional Law 312 during the Covid pandemic; helped organise several of the Chair's annual human rights lectures as well as editing them for publication; and supported and mentored several postgraduate students in the Chair over the years." Dr Van Schalkwyk has been awarded a two-year postdoctoral fellowship working with Professor Melanie Murcott at UCT in environmental rights. At the same time, he will also pursue publishing from his doctoral dissertation. All those associated with the Chair wish Dr Van Schalkwyk well in his new position. Although he will be greatly missed, the Chair will look forward

to future collaborations with him in his capacity as alumnus of the Chair.

#### **Professor Cathi Albertyn** delivers HF Oppenheimer Chair's 19<sup>th</sup> Annual Human Rights Lecture on **Substantive Equality**

On 9 April 2025, the HF Oppenheimer Chair in Human Rights Law, Professor Sandra Liebenberg and Professor Nicola Smit, Dean of the Stellenbosch University Faculty of Law, hosted the Chair's annual human rights lecture.

This year's speaker was highly renowned Professor Cathi Albertyn who currently holds the National Research Foundation Chair in Equality, Law and Social Justice at the University of the Witwatersrand. Given Professor Albertyn's deep expertise in equality law, it is no surprise that her lecture addressed the topic of "Substantive equality in South Africa: Past, present and future".

Professor Albertyn commenced her lecture by reminding the in-person and online audience of the startling fact that "formal equality is back, with a particular vengeance". She was referring to the recent rise of far-right politics, such as the Trump administration in the US and its remarks regarding race laws in South Africa. Highlighting this startling trend set the scene for how apt a time Professor Albertyn's lecture was and reinforced the immediate importance of developing a more transformative understanding of equality law in South Africa today.

After traversing equality's contested history in South Africa, Professor Albertyn remarked that her address would focus on the South African courts and their deliberation over the meaning of the right to equality. Focusing on our Constitution's demand for substantive equality and the related jurisprudence, Professor Albertyn explained the following characteristics as being instrumental in understanding what substantive equality entails: concern with group discrimination and disadvantage focusing generally on social not economic groups; concern with structural and systemic forms of power; focus on the nature of the harm that flows from differential treatment; concern with a contextual examination of differential treatment; and a focus on various values that may guide an equality assessment.

However, Professor Albertyn expressed that the country's jurisprudence in fact requires a more transformative understanding of substantive equality, that does not merely solely focus on dignity and equal concern and respect. Rather, equality should demand a focus on eradicating structural, social and economic disadvantage, allowing the achievement of individual well-being. Further, Professor Albertyn argued that the value of equality should play a more pivotal role in shaping our understanding of the right to equality. Here, Professor Albertyn highlighted the concept of "equality of condition" as a means to achieving true substantive equality in South Africa.

Expanding on the concept of "equality of condition", Professor Albertyn explained that this type of transformative jurisprudence would focus on multidimensional equality and intersectionality, while taking the factual context and effects of the law into account. Further areas that would need to be reorganised would include, for example, examining the private sphere, as well as addressing economic inequality in our country. Professor Albertyn pointed out that these future developments could be possible by drawing on existing case law.

Professor Albertyn ended her lecture by indicating that even though politics are crucial for delivering real change in a society, the courts and their jurisprudence matter. Professor Albertyn reminded the audience that their understanding of equality should enable transformative change in South Africa. This powerful reminder is timely and critical to achieving the society the Constitution demands in South Africa.

## Visual redress in the Faculty of Law: exciting inauguration of Room 1031 (Old Main Building)

The overall aim of the project of visual redress in the Faculty of Law is to transform the physical spaces of the Faculty into spaces that are welcoming to all and conducive to a positive learning environment. Apart from creating attractive visual spaces, the Faculty pursues:

- a. Memorialisation. Remembering past events, injustices, struggles and achievements, and inviting reflection on how the past continues to inform the present.
- b. Contextualisation. Placing the law (and past legal events and outcomes) in a historical and social context. The aim is to make the legal past more concrete, and to show how general laws and abstract legal concepts and principles impact(ed) on real people's lives and shaped and informed social relations and struggles.

c. Contestation. Showing that law is sometimes a space of contestation and struggle, and that court judgments, legal processes and the substance of the law are often subjects of controversy.

d. Critical reflection. The depictions of cases and

other manifestations of law and justice are meant to stimulate critical reflection on law, litigation and adjudication. Each depiction will and should be open to different interpretations.

e. Imagination. Reimagining the law, finding different lenses for looking at the legal past, and imagining more humane and just futures, in which all people living in South Africa will be free from the shackles of institutionalised racism, patriarchy, poverty, and other forms of marginalisation and structural disadvantage.

The visual changes in and around the Old Main Building over the past couple of years are in line with the Faculty's commitment to a critical inquiry into historical injustices and their continuing legacy, and the capacity of law-based processes (like visual redress) to challenge and transform social, economic, and political practices that result in inequality, degradation and oppression.

On Friday 9 May 2025, the Faculty of Law formally marked the completion of the first Storyboard Installation in its continuing visual redress initiatives.

Members of staff and SU management, as well as different role-players who have been involved in the conceptualisation and implementation of this multiyear project, attended this occasion.

During the inauguration of Room 1031, the Dean, Professor Nicola Smit, noted that: "Many of you will recall how this room once displayed portraits of former chief justices, predominantly reflecting a singular demographic. In the wake of transformative movements such as Rhodes Must Fall and Fees Must Fall, we recognised the need to reimagine our spaces - not as relics of the past, but as environments that reflect diversity, inclusivity, and the dynamic nature of our world and community."

This particular "storyboard" project, involves moving beyond traditional depictions, such as presiding officers, shifting the focus towards narratives that highlight pivotal legal cases and the people profoundly impacted by them. The theme of this first room is "Contractual and labour disputes - fairness, dignity, equality, freedom and social justice".

The Dean recalled that "Iblack in 2018, and again in March 2022, the Law Faculty reached out to students and staff to suggest appropriate cases to be shown on the storyboards ... It was quite challenging to imagine how to achieve this as we are not designers or artists but lawyers! The Transformation Committee was then given the task of taking this idea further ... The timeline of this initiative underscores the collaborative effort required - spanning public participation, inter-departmental cooperation, and dedicated resources." She concluded by stating that the Faculty's commitment to being forward-thinking, their embrace of visual redress initiatives, and their courage to imagine something new within the beautiful Old Main Building truly creates a community to be proud of.

As the Faculty's staff and students now embark on the next steps in its overarching visual redress project (Rooms 1017 and 2034), it looks forward to continuing to imagine, create, and nurture spaces that reflect who we are and who we aspire to be.

Following these insightful presentations, Mr Gosai (Stellenbosch University Student and intern at Capitec Bank) and Mrs Hendricks (Specialist: Early Careers) engaged with students on the topic of careers at Capitec, highlighting the fulfilling and cooperative nature of their career opportunities. The event was concluded by an informative question and answer session, after which students and guests enjoyed refreshments in the Quad.

#### 16<sup>th</sup> ATAX International Conference on Tax Administration

From 8 to 9 April, Ms Zinhle Novazi had the privilege of attending and co-presenting a co-authored paper, with Ms Khodani Tshidzumba-Sengwane (Lecturer at the University of Pretoria), at the 16<sup>th</sup> ATAX International Conference on Tax Administration, held in Sydney, Australia. The conference brought together global experts in tax law, policy, and administration to explore innovative strategies for improving tax systems worldwide.

The paper, titled "Cracking the crypto code: SARS' approach to taxing the untouchable", critically examines the South African Revenue Service's (SARS) approach to taxing crypto assets. The paper unpacks the legal and administrative challenges SARS faces in this evolving space, and offers recommendations for a more agile, transparent, and effective regulatory response.

The programme featured keynotes from leading tax authorities, including Mr Rob Heferen, Commissioner of the Australian Taxation Office, who shared how Australia has achieved a 90.9% voluntary compliance rate through targeted interventions. Mr Peter Mersi, Commissioner and CEO of New Zealand's Inland Revenue Department, also shared insights on the benefits of automated income assessments and data-driven compliance.

Ms Novazi reflects, "One powerful insight from the conference is the importance of academic voices in shaping policy, industry practice, and social progress. In times marked by rapid technological change and economic uncertainty, we are not just observers of these shifts - we are essential contributors to the knowledge that drives them."



# 2<sup>nd</sup> Annual Criminal Justice Colloquium

Two colleagues from the Department of Educational Psychology, Dr Sifiso Shabangu and Professor Melanie Moen, also presented their research at the Colloquium ("Empirical findings on filicide offenses in eSwatini").

# Association for Law, Property & Society (ALPS) 2025 Conference

In the last week of May, Professor Zsa-Zsa Boggenpoel and Dr Tanveer Jeewa attended the 2025 Annual Association for Law, Property & Society (ALPS) Conference hosted by the University of Sydney. ALPS is an open international organisation of scholars and teachers engaged in a wide range of interdisciplinary research covering all aspects of property law, policy, and theory, and the role property plays in social structures, human relationships, and ecology.

Professor Boggenpoel presented an article, entitled "Unpacking the notion of 'suitable alternative accommodation': What do we mean with this notion and how is it applied in South African law?", which elaborated on her most recent research on the "safe spaces" in Cape Town - shelters designed to accommodate homeless people in the area. Her presentation focused on whether these facilities constitute suitable alternative accommodation for evictees, and what this choice of shelter means for eviction jurisprudence on a national scale. The Conference was an invaluable opportunity to obtain feedback on comparative jurisdictions and their approaches to alleviating homelessness, even temporarily.

Dr Jeewa presented her co-authored article with Prof Boggenpoel, entitled "Neighbour law or apartheid's echo? Unlawful occupation and the misuse of public nuisance doctrine". The article explored the persistent misapplication of public nuisance doctrine in cases of unlawful occupation and the racialised harm this perpetuates in post-apartheid South Africa and beyond. The presentation sparked rich discussions and critical reflections on the wider role of property law in society.

These engagements reaffirmed the value of international scholarly exchange - not only in sharpening legal inquiry, but in building a more inclusive academic community invested in justice, reflection, and meaningful reform.

# 14<sup>th</sup> Counter Fraud, Cybercrime and Forensic Accounting Conference

Professor Delano van der Linde presented a paper titled "Understanding and combating business email compromise fraud in the South African context" at the 14th Counter Fraud, Cybercrime and Forensic Accounting Conference, hosted at the University of Portsmouth (18 to 19 June). Professor Van der Linde's presentation focused on the growing risk of cybercrime (particularly business email compromise) in South Africa, and focused on the recent judgments in *Edward Nathan Sonnenberg Inc v Judith Mary Hawarden* 2024 (5) SA 9 (SCA) and *Ross and Another v Nedbank Limited* (10029/2020) [2024] ZAGPJHC 1146 (8 November 2024). He also considered whether South Africa's criminal justice infrastructure is equipped to deal with these prevalent crime forms.

Ms Rukshana Parker, a lecturer in the Department of Private Law, recently spent three weeks at the University of Groningen in the Netherlands conducting research for her doctorate. Her study examines the effect of religious polygamous marriages and



domestic partnerships on the intestate inheritance rights of descendants.

During her time in Groningen, she was based at the Notarial Institute, which is internationally recognised for its expertise in succession law. She engaged with scholars in the field, attended lectures, and presented her research to faculty members. The visit also enabled valuable conversations with academics whose research intersects with hers, opening the door to potential future collaborations.

The comparative aspect of her doctoral research draws on Dutch inheritance law; thus, the visit to Groningen provided excellent access to legal materials, institutional insight, and scholarly expertise. She describes the atmosphere at the university as welcoming and intellectually generous, with informal moments - including faculty dinners and everyday office chats - often sparking stimulating academic discussion. The experience has not only enriched her research but also reaffirmed the importance of global academic exchange and collegial engagement.

## First-year welcoming programme

uring the Law Faculty's Welcoming Programme, the new first-year group of 2025, along with their parents and guardians, met the Dean and selected staff in the Endler Hall of the Conservatory, on Tuesday, 28 January. Wednesday marked yet another full day of activities across from the Old Main Building, where the students officially began their journey in preparation for the academic year ahead. The programme, featuring guest lectures from some of the staff, focused on giving students the invaluable opportunity to connect with one another. A particular highlight was the annual first-year law student welcoming luncheon, generously sponsored by Werksmans Attorneys, held in the spacious Simonsberg Residence, which comfortably accommodated the approximate 250 students in attendance.

The rest of the programme, spanning the latter half of the week and continuing until the following Wednesday, featured a series of informative sessions. These covered topics such as the anticipated differences between school and university; the academic calendar of the year ahead; the weekday of the 'ideal law student'; consequences of misbehaviour as a student (and the possible impact of this on future career options); ethical requirements to be admitted as a legal practitioner; as well as the various support services that are available on campus, which also included programme-specific information sessions, targeting the various law programme articulations.

The JV/S and various societies active within the Faculty, which included the Moot Society, Students for Law and Social Justice, the Black Lawyers Association, Stellenbosch Chapter, and the Student Court, were also present. On Wednesday, 5 February, after meeting their respective first-year lecturers, the Dean wished them well with the start of the academic year - thereby bringing to a close the 2025 iteration of the Welcoming Programme.





The annual Pledge Ceremony was held on the final day of the first semester, 16 May. To help celebrate this special occasion, the Judge-President of the Cape High Court, JP Mabindla-Boqwana, and her colleague Judge Nuku, were in attendance.

Prior to the Pledge Ceremony, the Judge-President addressed the first-year group in their final Legal Skills 114 lecture, and spoke to them about the critical importance of the rule of law in South Africa; the meaningful role that law students will play as future graduates; and a day in the life of a judicial officer against the backdrop of transformation imperatives within all facets of the profession. Hereafter, Judges Mabindla-Boqwana and Nuku engaged with our students in answering their questions, before crossing the road to the Old Main Building, to commence with the Pledge Ceremony.

After a welcoming and address by our Acting Dean, Professor Juanita Pienaar, the group was addressed by the current Chair of the JV/S, Ms Alexia Cawood, and former Chair, now colleague, Ms Lerato Melato on what lies ahead in their journey as future jurists. In her address, Ms Cawood remarked:

"I remember my own pledge ceremony vividly - right here in the courtyard of the Ou Hoofgebou. We were masked, uncertain, and just beginning to grasp what it meant to step into the world of law. That night felt like the start of something much bigger than myself. It was the moment I decided not just what kind of law student I wanted to be, but what kind of person I wanted to become.

Tonight is not simply ceremonial. It is meaningful. You are not just signing a document - you are making a commitment. A commitment to uphold the values of integrity, fairness, and discipline. A decision to hold yourself to a higher standard, even when it is difficult. Especially when it is difficult.

In this field, you will often face a choice: to take the easier path, or to take the right one. The right path may require you to say no - to friends, to comfort,



to shortcuts. But that same path builds the kind of character that defines what it means to be fit and proper.

Law is exciting, but it is also deeply serious. It shapes the lives of people - especially the vulnerable, the unheard, and the unseen. Your words, your research, your arguments - they matter. They will carry weight in the lives of others, sometimes in ways you may never fully realise.

As you move forward from your final Legal Skills lecture today, take with you not just the tools of reading and writing the law, but the responsibility of being the law in action. The Preamble of our Constitution begins with the words: 'We, the people of South Africa...' This is not just a phrase. It is a call. The healing, the justice, the transformation of this country - it begins with us. With you. you wish you had when you were younger. Let your studies be more than a pursuit of marks - let them shape your character. Grow from every case you read, every debate you have, every mistake you make. And when you're faced with a choice to compromise your values, remember this night. Choose the harder path. Choose the path that builds a more accountable, more just South Africa.

Congratulations on making it this far. Tonight, we send you forward - not just as students, but as future custodians of justice."

Thereafter, Dr Greenhalgh read out the wording of the Preamble of the Constitution, before the students proceeded to sign their Pledge Document, which they handed over to the Acting Dean and Judges Mabindla-Boqwana and Nuku and, in return, they received personalised copies of the Faculty's Code of Conduct and the Constitution.

# Renewed Postgraduate Diploma in Tax Law

In February, the Faculty welcomed students to its first intake of the renewed Postgraduate Diploma in Tax Law. This part-time, in-person programme is offered over a two-year period, at the Stellenbosch campus, with classes and assessments taking place on several Saturday mornings. The diploma is a unique qualification for individuals with a legal or accounting background, and requires a law, accounting or commerce undergraduate degree for admission. The 120-credit programme at NQF level 8 comprises four modules: Foundations of Tax Law (with emphasis on tax administration), Principles of Income Tax Law, Law of Selected Taxes (including donations tax, estate duty, value-added tax and transfer duty), and International & Further Tax Law (including the legal aspects relating to the taxation of companies, dividends and trusts, as well as anti-avoidance). The four modules introduce students to South African tax law principles, offering a comprehensive understanding of the legal framework governing taxation in South Africa. Emphasising the

practical application of these principles, the modules enable students to analyse factual scenarios, identify pertinent legal issues, develop solutions, and provide advice. Professor Izelle du Plessis, Dr Enelia Jansen van Rensburg, and Ms Silke de Lange are the lecturers in the diploma. The next intake will be in January 2027.

#### HUYSAMEN, Elsabé (Mercantile Law)

The future of a prohibition on indirect unfair discrimination as part of South African antidiscrimination employment law: A comparative reflection

Equality in employment is promoted through a combination of a prohibition on direct and indirect unfair discrimination, and the implementation of affirmative action. Among these mechanisms, the prohibition on indirect discrimination holds significant potential as a transformative tool, departing from the premise that equal treatment may have unequal outcomes. This study analyses this transformative potential, as well as the reasons why indirect discrimination has enjoyed scant attention in South African workplaces, especially compared with the United States, United Kingdom and Canada. The research affirms the need for a continued role for the concept and makes proposals for its efficient dissemination.

#### JANSEN, Gretchen Sulene (Mercantile Law)

A critical examination of performers' rights to remuneration as an effective protective mechanism for commercial musicians in South Africa

The plight of South African commercial musicians has been observed for decades, with the relationship between musicians and record companies playing a central role. In this regard, the role of performers' rights under the Performers' Protection Act 11 of 1967 is often overlooked. This study examines how performers' rights to remuneration can help improve musicians' financial outcomes. It calls for stronger protection of performers' rights, along with more robust regulation of collective management organisations entrusted to administer such rights, to ensure fair and equitable remuneration for musicians from the commercial exploitation of their music.

#### JEEWA, Tanveer Rashid (Public Law)

Using the master's tool to secure the occupiers' house: Expropriation as appropriate and effective relief in cases of mass unlawful occupation

South Africa's housing crisis has led to mass unlawful land occupations, reinforcing apartheid-era spatial inequalities. This study canvasses a definition for mass unlawful occupation, expands on a critical transformative property theory, and proposes an innovative remedial framework. Existing legal remedies fail to balance landowners' rights with occupiers' protection from eviction. The research advocates for statutory expropriation as a viable solution. By amending section 9(3) of the National Housing Act, the state can acquire occupied land, ensure secure tenure for occupiers, and address landowners' concerns – offering a principled, practical response to this urgent issue.

#### LETLONKANE, Katlego Princess (Mercantile Law)

Social Justice at the Commission for Conciliation, Mediation and Arbitration (CCMA) and the Critical Role of the Commissioner

This study provides exploratory insight into the social justice mandate of the Commission for Conciliation, Mediation and Arbitration (CCMA) and its most critical functionary, the Commissioner. The main objective is to transform the pursuit of social justice from an elusive endeavour to a more tangible, realistic one. The research offers a way of thinking about and applying social justice by engaging the interwoven power asymmetries and bias in labour relations, presenting a transformative lens that integrates ubuntu. The study advocates for the empowerment of CCMA Commissioners to take up their role as social justice agents and disrupt workplace inequality.

#### UYS, Hugo (Public Law)

#### Framed and caged: Theorising the vulnerability of animal bodies before the law

Despite laudable aims, animal advocacy efforts remain ineffective at realising a widespread transformation of human-animal relations. One significant challenge is the law's failure to confront its own complicity in enabling and maintaining the ongoing subjugation of animals. In the pursuit of animal liberation, this study offers a sympathetic critique of animal law. To this end, it reads critical legal theory together with the emerging posthumanities to think through the entanglement of bodiment, animality and law. Ultimately, the study offers a post-disciplinary articulation of a renewed juridical imaginary with which to pursue the future emancipatory and post-anthropocentric development of animal law.

#### VAN SCHALKWYK, Christiaan (Public Law)

Integrating environmental considerations in socioeconomic rights adjudication: The role of ecologically sustainable development

The intersecting threats that the ecological crisis poses to human rights require a recognition of the interdependence between socioeconomic and environmental rights. Of particular importance is the responsiveness of socioeconomic rights adjudication to the convergence of socioeconomic and environmental disadvantage. This study explores how the concept of sustainable development in section 24(b)(iii) of the Constitution should serve as a bridge to operationalise the interdependence between socioeconomic and environmental rights. It makes recommendations on how environmental considerations could be integrated in all stages of socioeconomic rights adjudication, including interpreting the normative content of rights and broadening the reasonableness standard of review.

# 2024 Top Academic Achiever Prize Announcement 2024 Top Akademiese Presteerder-Prys Aankondiging

The alumni of the Faculty annually fund various bursaries for financially needy and academically deserving students. However, until 2020, exceptional academic achievement has never been recognised specifically. In 2020, the Law Faculty Trust first introduced a prize (amounting to R200 000, which approximately covers the tuition cost of a legal qualification) awarded to an academic top achiever.\*

Following the 2024 academic year, we can now announce the fifth recipient of this award: Chris Malherbe, a BAccLLB (cum laude) graduate. He works as an Associate at Bain & Company in Johannesburg and serves as an International Editor of the Cambridge Law Review. Congratulations, Chris!

We sent Chris some questions, compiled by current law students, to hear more about his experience at the Faculty:

#### 1. As jy 'n alternatiewe studierigting en loopbaan moes kies, wat sou dit wees?

Ekonomie. My ideale werk is om 'n skrywer vir die Economist te wees.

#### 2. When you think of the Stellenbosch Law Faculty, what image or idea comes most strongly to mind?

I picture a blend of classic character and progressivism. Stellenbosch has always felt like home to me, but the Faculty introduced me to so many new ideas.

#### 3. Waar is jou gunsteling plek om te studeer?

By die huis. Ek het op 'n wynplaas in Stellenbosch grootgeword. Ek het 'n plekkie op die boonste verdieping van 'n toring in 'n wynkelder gehad met panoramiese uitsigte oor die wingerde. Ek het gereeld daar gestudeer, veral tydens Covid - die natuurskoon was ongelooflik.

#### 4. Why did you choose to study law, and why at the Stellenbosch Law Faculty?

I chose law because it's about so much more than just the letter of the law. It taught me how to think more clearly, how to make cohesive arguments, and how to be comfortable with ambiguity. Ultimately, I'm not using the law directly in my life, but indirectly, it makes all the difference.

#### 5. Wat is 'n kosbare herinnering van jou studentejare? Die avonture in die berge saam met my vriende.

#### 6. What was your most enjoyable module and why?

Interpretation of Enacted Law. This surprised me, since initially I was quite sceptical about the module. I felt like I gained many fundamental, systematic ways of thinking about issues. Despite not working in law, it still influences my thinking to this day.

#### 7. Wie was jou gunsteling dosent, en hoekom?

Dis moeilik om net een te kies. Professore Sandra Liebenberg, Richard Stevens en Christoph Garbers was werklik ongelooflik - nie net ten opsigte van hul kennis nie, maar ook as gevolg van hul belangstelling in my ontwikkeling.

8. What advice would you give a fellow law student who is struggling to manage the workload? And what is your approach to large volumes of work?

Focus on the core ideas and principles and condense the content without losing its essence. My memory is fairly average, so pure memorisation was rarely my approach. Law school isn't about memorising everything. It's more about finding the truly important substance and knowing how to apply it properly. Also, going into gloomy spirals of despair about the workload won't make it go away - it's best to be as pragmatic and optimistic as possible.

#### 9. Luister jy na musiek wanneer jy studeer? Indien wel, wie is jou gunsteling kunstenaar/groep of gunsteling genre?

Ek luister altyd na musiek wanneer ek analitiese werk doen of opsommings maak. Ludwig Göransson is al jare lank bo-aan my lys op Spotify. Anders luister ek obskure Duitse rap.

#### 10. Do you believe it is important to have a studying/ social life balance?

Absolutely. I worked extremely hard throughout university (sometimes notoriously so), but I always made time to spend time with my friends and family. I also had a few personal non-negotiables: never work past 8 PM, exercise at least three or four times a week, eat healthily, and the like. These will naturally differ from person to person, but I felt like having clear boundaries made the mental aspect of things much more manageable.

#### 11. Wat is jou belangstellings buite die reg en is dit belangrik om sulke belangstellings te hê?

Openbare beleid, skaak, UFC, en reis (veral na minder gewilde lande). Baie min mense hou genoeg van hul studies of loopbaan dat dit hul enigste bron van stimulasie is, en ek is geen uitsondering nie.

#### 12. What are your plans for the future?

I'm currently working for Bain & Company and will transfer to either their Copenhagen or Sydney offices in the next few months. I try not to plan too far ahead, but I wouldn't be surprised if I pursue an LLM in the US (Harvard has always been a dream) and eventually return to South Africa to work in public policy. A certainty, though, is that all roads lead back home.

#### 13. Wat is die waardevolste vaardigheid/eienskap/ kennis wat jy uit jou regstudies opgedoen het?

Die belangrikste was om 'n sterk werksetiek te ontwikkel. BRekLLB se werklas is baie inspannend, dus dink ek werklik dat dit een van die belangrikste eienskappe is wat 'n persoon kan ontwikkel.

#### 14. What advice do you wish you had been given as a first-year student?

Not to let one bad result ruin your day. My very first

law test - Criminal Law - went quite badly, and I was immediately questioned whether law was for me. It turned out that the mental turmoil after that test, and many others, was unnecessary. Don't let slips change your perception too much.

#### 15. Waar is die beste koffieplek op kampus? Häzz was die beste, en ek is steeds hartseer dat hulle toegemaak het.

#### 16. What is your favourite Social Media App to use as a break from studying?

I avoid most forms of social media, since I think these typically take far more than they give. But if I had to

pick one, it's probably Strava.

#### 17. Wat is erger, klas om 08:00 of 16:00?

Klas om 16:00 is beslis erger. Om die tamheid in die middag te oorkom, het ek gewoonlik in hierdie gleuf gaan draf wanneer ek nie klas gehad het nie.

#### 18. Do you have a particular method for studying and note-taking?

I made "executive summaries" of everything - cryptic, concise, and hyper-personalised notes. It allowed me to work through the content far quicker, leaving more time for deeper thinking about more complex parts of the work.

# Moot Court

Stellenbosch University was represented at the 34<sup>th</sup> Christof Heyns African Human Rights Moot Court Competition, which took place from 29 June to 5 July 2025 at the University of Cape Town. The University's team comprised Ms Isabelle Scribante and Ms Carolyn Laker, who were coached by Dr Anisa Mahmoudi.

This year's competition featured a complex hypothetical case before the African Court on Human and Peoples' Rights between the African Commission on Human and Peoples' Rights (representing the Association for Zambezian Migrants) and the fictional state of Baharia. The case engaged with pressing human rights issues including nationality rights, statelessness, electoral rights, migrants' rights, and state obligations toward non-citizens.

The Christof Heyns African Human Rights Moot Court Competition, named after the late renowned human rights scholar and UN Special Rapporteur, continues to be Africa's premier platform for aspiring human rights lawyers to hone their advocacy skills on contemporary human rights challenges facing the continent. The team reached the quarter-finals. They placed 8<sup>th</sup> overall in the Preliminary Rounds, and Ms Laker was ranked 7<sup>th</sup> in the Best English Oralist category. Congratulations to the team.

#### **Successful Relocation of Nooitgedacht Farm Occupiers**

In June 2024, the Clinic was approached by of 15 households representatives living on Nooitgedacht Farm, in Stellenbosch, to assist with negotiations regarding their potential relocation from the farm. The farm owner offered to purchase each household a property in a housing development in Klapmuts.

After months of dedicated engagement with the occupiers and the farm owner's attorneys, 13 households signed relocation settlement agreements in September 2024, with the final two households following in January and February 2025.

The Law Clinic is pleased to share that, on 18 and 19 February, all their clients successfully moved into their new homes in Klapmuts. Their properties are now in the process of being registered in their names, ensuring security of tenure for generations to come. As part of its ongoing support, the Clinic will also assist these new homeowners with drafting their wills.

## **Empowering Young Voices:** SULC's Children's Rights Project

In the first term of 2025, the Law Clinic visited nine primary schools in and around Stellenbosch as part of its ongoing Children's Rights Project. Through this initiative, the trained Candidate Legal Practitioners (CLPs) presented engaging, age-appropriate sessions to learners aged six to nine, educating them about their rights and responsibilities in a fun and interactive way.

Over the course of the term, the project reached a total of 817 Grade 1 to 3 learners. The impact of the sessions was clearly reflected in the data:

- There was an estimated 47% increase in the number of learners who could identify what a "right" is.
- There was a 47% improvement in understanding what a "responsibility" is.
- Most notably, there was a 62% increase in learners who knew whom to approach when feeling scared or unsafe.

The CLPs strive to deliver informative and empowering sessions while keeping young learners focused and involved and the feedback from schools has been

overwhelmingly positive. Educators consistently highlight how well the sessions align with their curriculum and how much the learners enjoy the CLPs' engaging, relatable approach. Teachers noted that learners were enthusiastic participants and expressed a keen interest in having the Law Clinic return in the future.

The Clinic is proud of the work being done through the Children's Rights Project and look forward to reaching even more young voices in the terms ahead.
